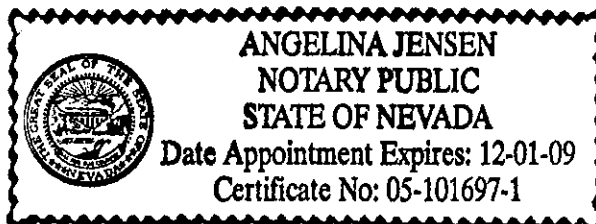

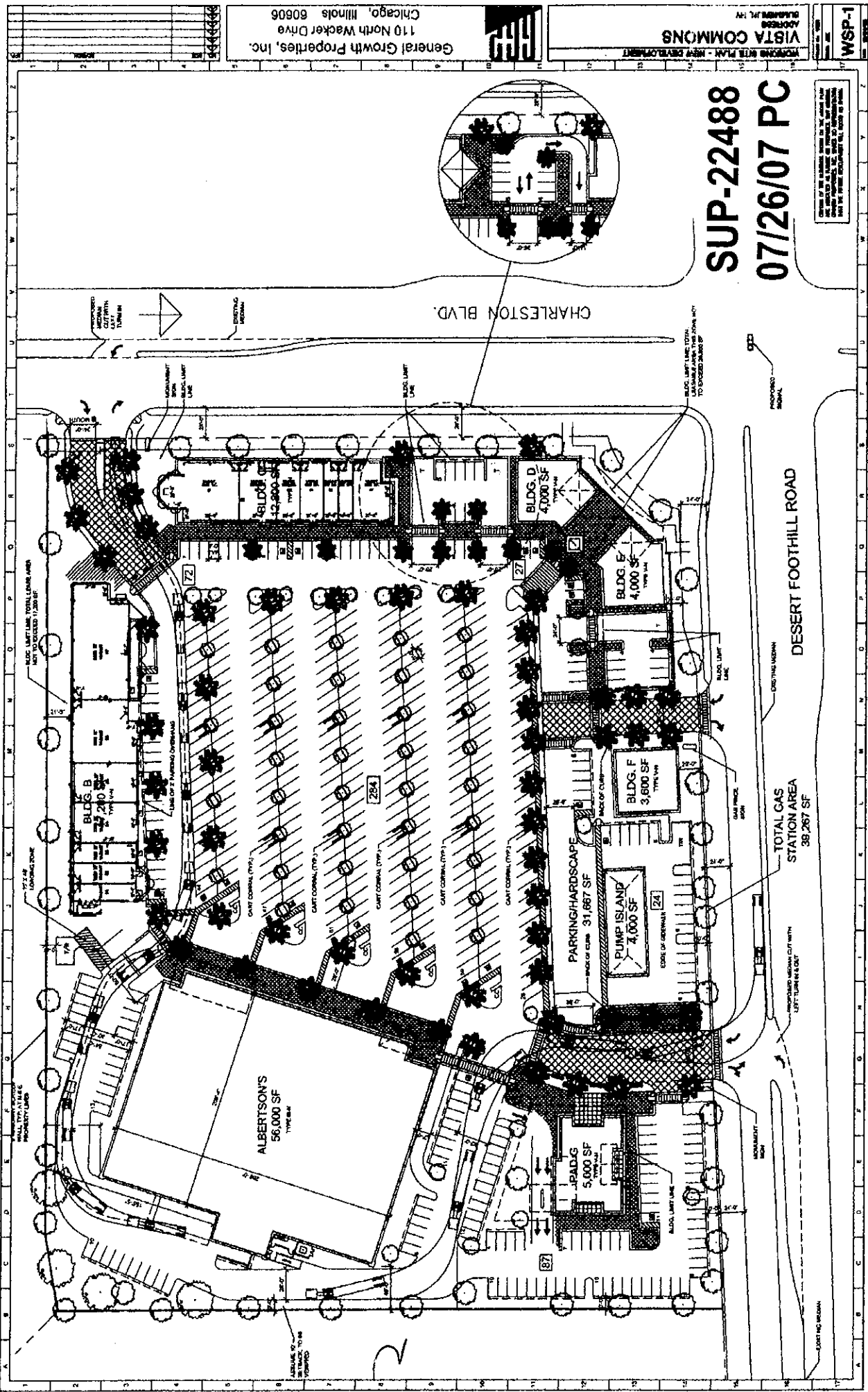
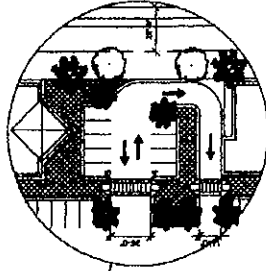


WISCONSIN SITE PLAN - NEW DEVELOPMENT

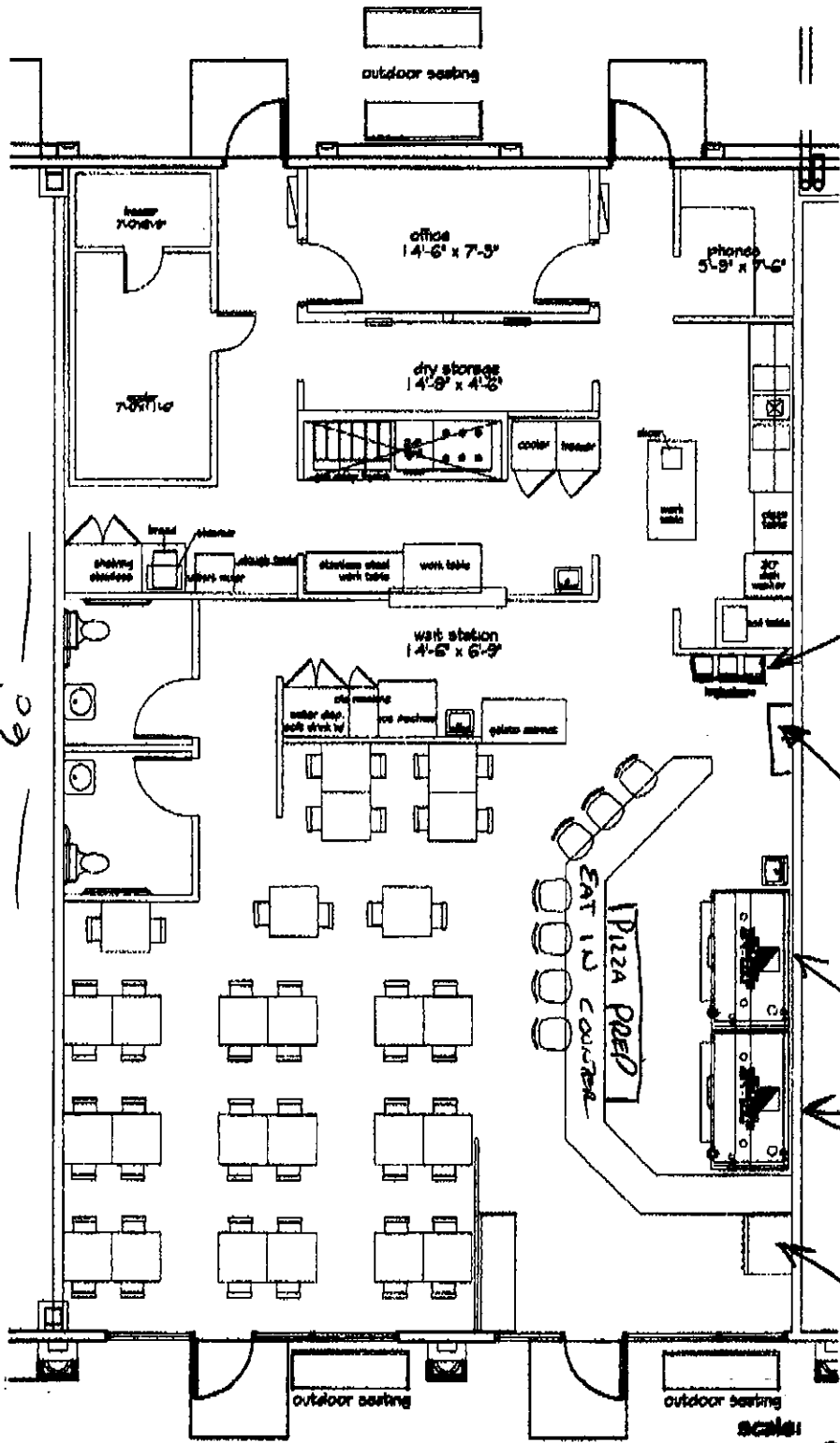
