**** CONDITIONS ******STAFF RECOMMENDATION: DENIAL.** If Approved, subject to:**Planning and Development**

1. This Special Use Permit shall be reviewed in three (3) years at which time the City Council may require the Off-Premise Advertising (Billboard) Sign be removed. The applicant shall be responsible for notification costs of the review. Failure to pay the City for these costs may result in a requirement that the Off-Premise Advertising (Billboard) Sign is removed.
2. The Off-Premise Advertising (Billboard) Sign and its supporting structure shall be properly maintained and kept free of graffiti at all times. Failure to perform the required maintenance may result in fines and/or removal of the Off-Premise Advertising (Billboard) Sign.
3. The property owner shall keep the property properly maintained and graffiti-free at all times. Failure to perform required maintenance may result in fines and/or removal of the Off-Premise Advertising (Billboard) Sign.
4. If the existing off-premise sign is voluntarily demolished, this Special Use Permit shall be expunged and a new off-premise sign shall not be permitted in the same location unless a Special Use Permit is approved for the new structure by the City Council.
5. The applicant shall clean the Off-Premise Advertising (Billboard) Sign of all bird droppings within 30 days of final approval.
6. The applicant shall remove the razor wire on the Off-Premise Advertising (Billboard) Sign within 30 days of final approval.
7. Bird deterrent devices shall be installed on the sign within 30 days of final approval by the City of Las Vegas.
8. All City Code requirements and design standards of all City departments must be satisfied, except as modified herein.

**** STAFF REPORT ****

PROJECT DESCRIPTION

This is a request for a Required Two Year Review of an approved Special Use Permit (U-0262-94) which allowed a 14-foot x 48-foot Off-Premise Advertising (Billboard) Sign at 4820 West Charleston Boulevard.

This is the fourth review of the subject Off-Premise Advertising (Billboard) Sign. The Off-Premise Advertising (Billboard) Sign does not have a final inspection on the original building permit. It is also noted that a site inspection conducted on 06/25/07 showed that the Off-Premise Advertising (Billboard) Sign contains bird droppings, and razor wire. Conditions of approval have been added to address these issues. Due to the failure to comply with Code requirements, denial of this request is recommended.

ANALYSIS

This is the fourth review of the subject Off-Premise Advertising (Billboard) Sign. The Off-Premise Advertising (Billboard) Sign does not have a final inspection on the original building permit. It is also noted that a site inspection conducted on 06/25/07 showed that the Off-Premise Advertising (Billboard) Sign contains bird droppings, and razor wire. Conditions of approval have been added to address these issues.

The Off-Premise Advertising (Billboard) Sign is located on a property that is used as a car wash. The Off-Premise Advertising (Billboard) Sign faces Charleston Boulevard a 100-foot Primary Arterial. The area is primarily commercial in nature with the nearest residential uses buffered by right-of-way and commercial development.

FINDINGS

The subject Off-Premise Advertising (Billboard) Sign fails to meet all Code requirements. There has not been a final inspection on the building permit, the sign contains bird droppings and razor wire. Due to the failure to comply with Code requirements, denial of this request is recommended.
