The City Council at a regular meeting held July 12, 2006 APPROVED the Appeal filed by the applicant from the denial by the Planning Commission of a request for a Special Use Permit FOR A MASSAGE ESTABLISHMENT AND A WAIVER OF THE 200 FOOT DISTANCE SEPARATION REQUIREMENT FROM A RESIDENTIAL USE at 1215 South Las Vegas Boulevard (APN 162-03-112-029), C-2 (General Commercial) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on July 13, 2006. This approval is subject to:

Planning and Development

1. Approval shall be subject to a one-year review and is pursuant to the site plan date stamped 6/21/2006 and floor plans submitted 7/12/2006.
2. There shall be no in-room massages.
3. Conformance to all Minimum Requirements under LVMC Title 19.04.050 for a Massage Establishment use.
4. This approval shall be void one year from the date of final approval, unless a business license has been issued to conduct the activity, if required, or upon approval of a final inspection. An Extension of Time may be filed for consideration by the City of Las Vegas.
5. Trash receptacles on the site shall be enclosed within a structure that meets current Title 19 standards.
6. A minimum of four handicap accessible spaces shall be provided on the site.
7. Graffiti shall be removed from all structures on the subject property, including walls.
