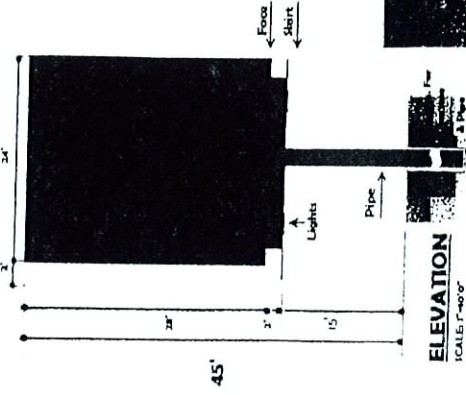




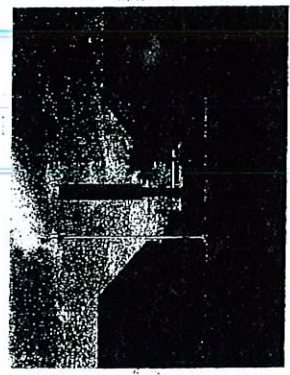

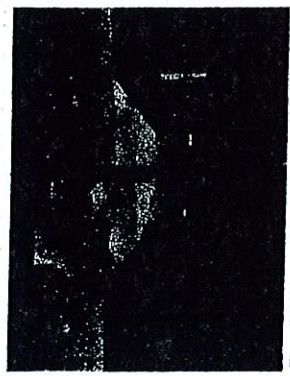
PLAN VIEW



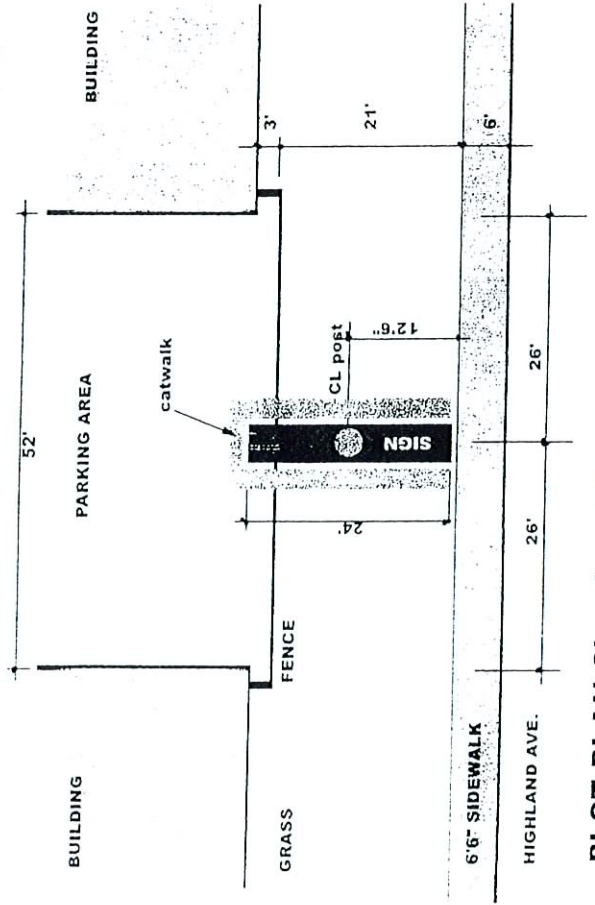

End View Southern Sign (1)

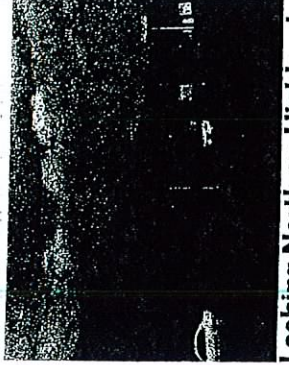


End View Northern Sign (2)

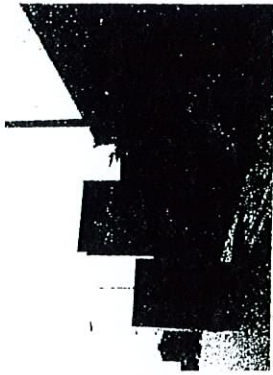

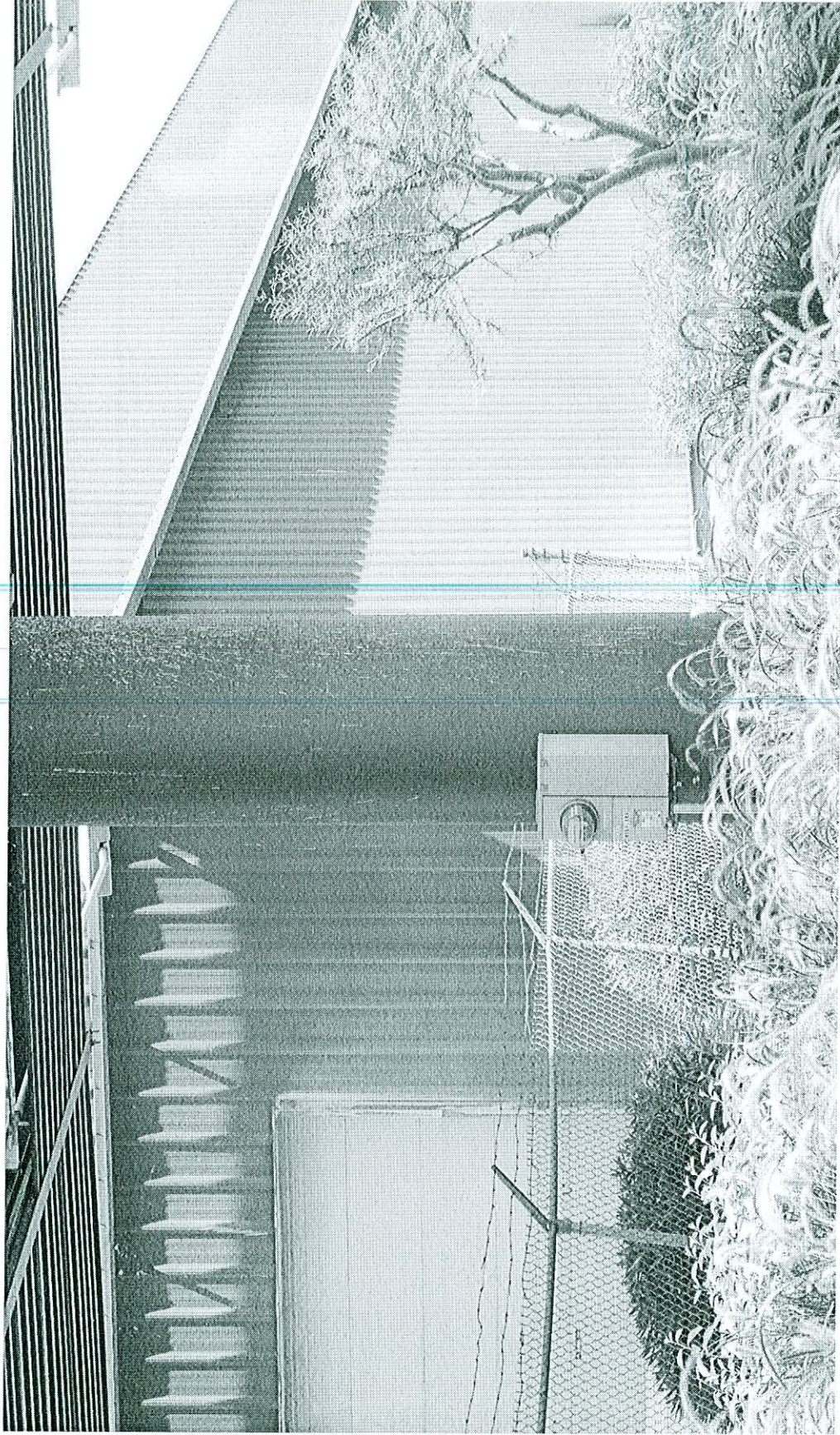
