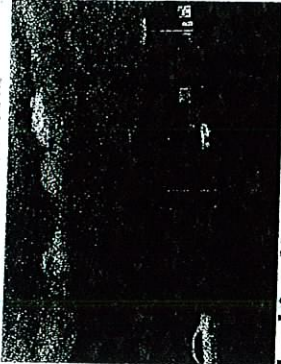




**End View Southern Sign (1)**

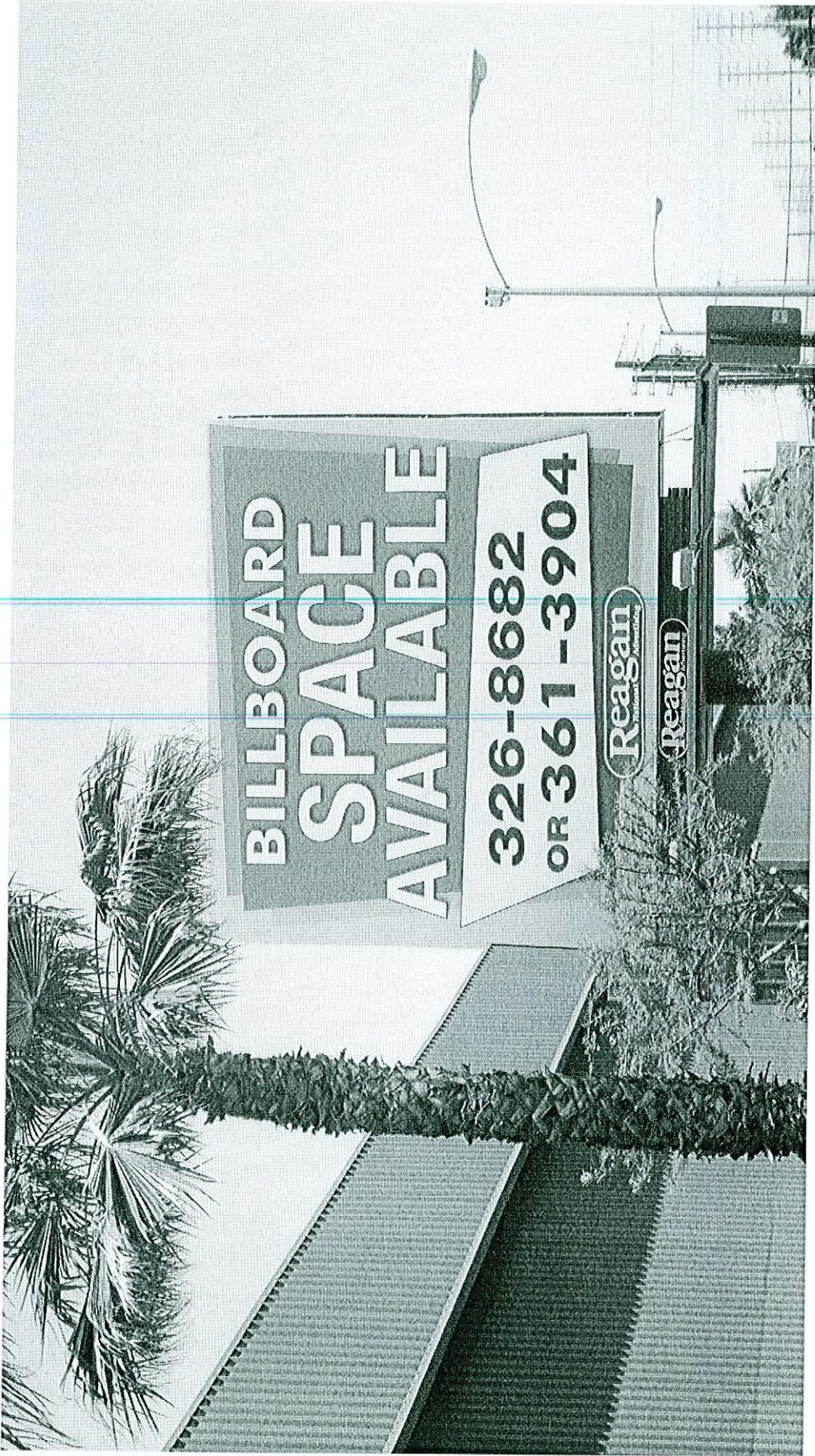
