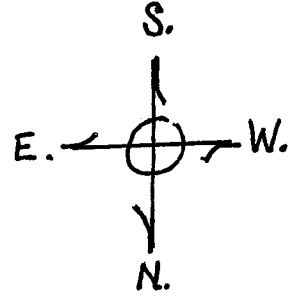

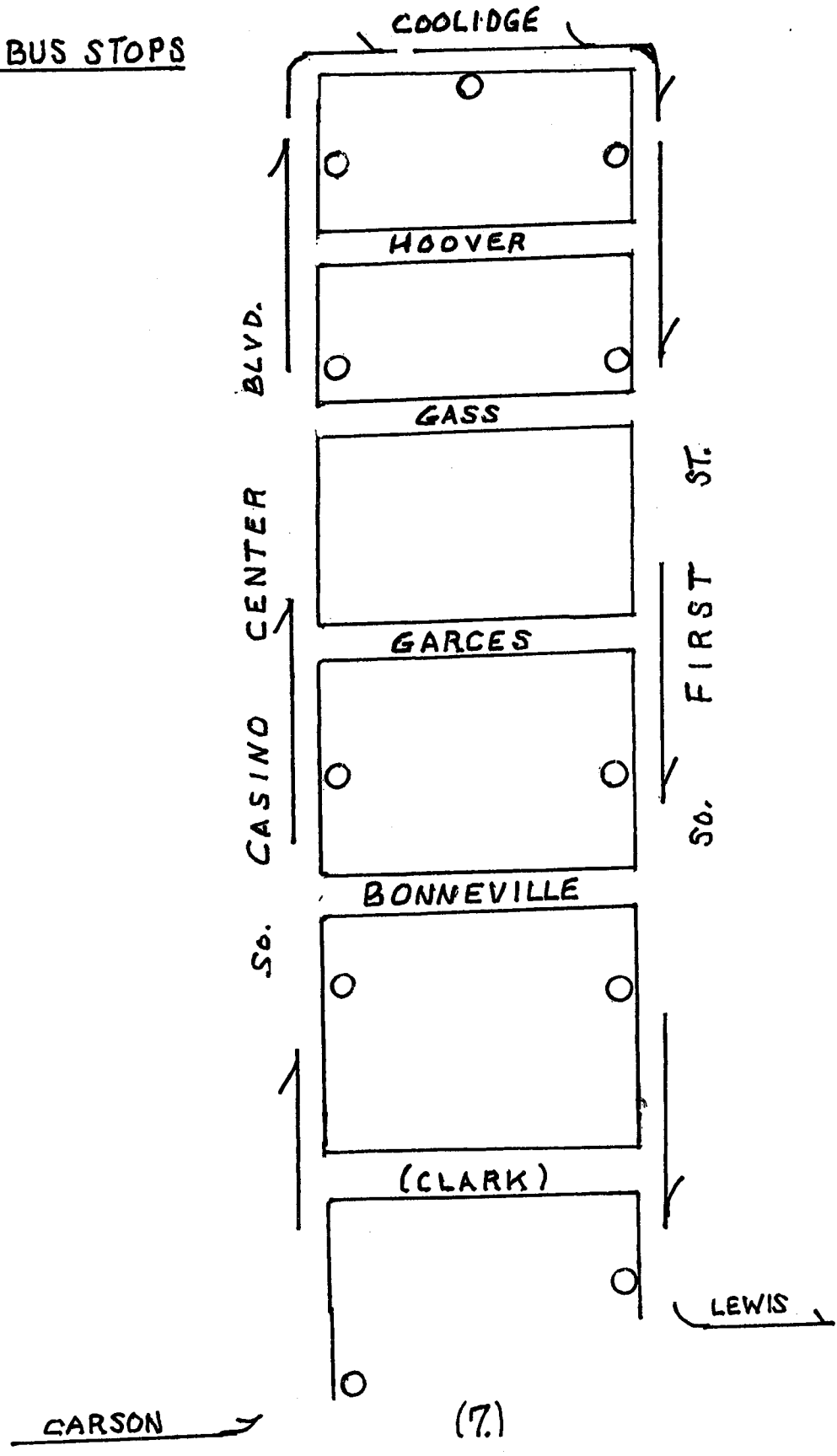

AT 2pm YESTERDAY (10 JULY), I WAS ADVISED BY CITY MANAGER DOUG SELBY THAT, ~ STARTING MONDAY 16 JULY, AND CONTINUING FOR THIRTY (30) DAYS, ~ THE BLUE 'CITY RIDE' BUS ROUTE WILL BE EXTENDED SOUTH ALONG CASINO CENTER BLVD. TO COOLIDGE AVE.; WEST ON COOLIDGE AVE. TO FIRST ST.; THEN NORTH ON FIRST ST. TO CLARK AVE., AND BACK ON ITS REGULAR ROUTE TO THE DTC, THROUGH THE DOWNTOWN CENTRAL BUSINESS DISTRICT AND FRENCH EAST, TO ALBERTSON'S MARKET IN THE CHARLESTON PLAZA, AND RETURN. THE REGULAR FARE IS .50¢ FOR ADULTS; THE REDUCED FARE IS .25¢ FOR SENIORS AND DISABLED PERSONS. THE 'CITY RIDE' SOUTH EXTENDED LOOP

WILL SERVE THE PUBLIC MASS TRANSIT NEEDS OF ALL RESIDENTS OF THE ARTS DISTRICT BOUNDARIED BY: MAIN ST., FOURTH ST., CHARLESTON BLVD. AND CLARK AVE., AND WILL UNITE ALL RESIDENTS OF THE GREATER DOWNTOWN AREA IN THE SPIRIT OF GENUINE COMMUNITY.

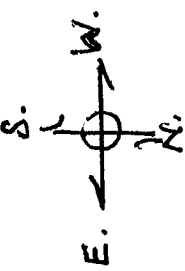
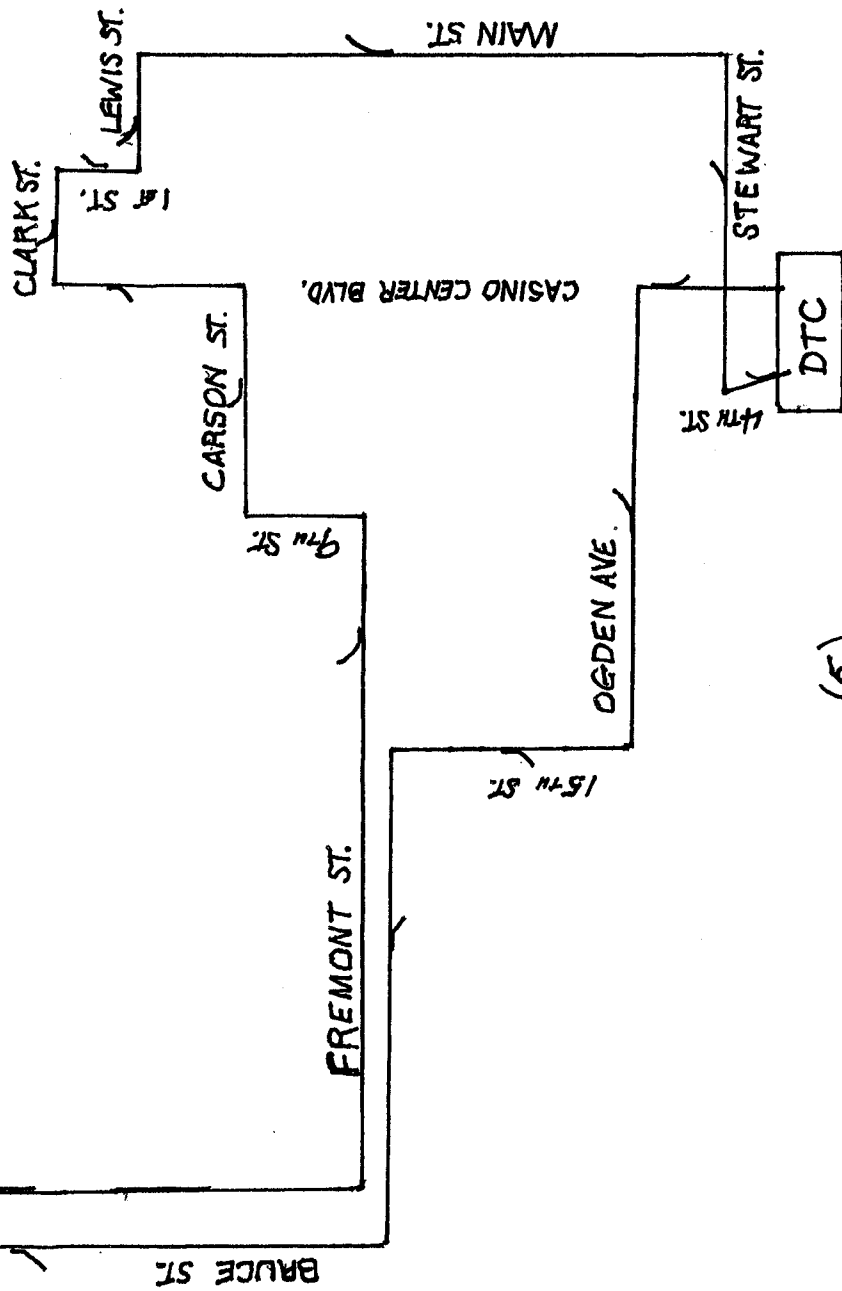

CURRENT: DOWNTOWN EAST LOOP

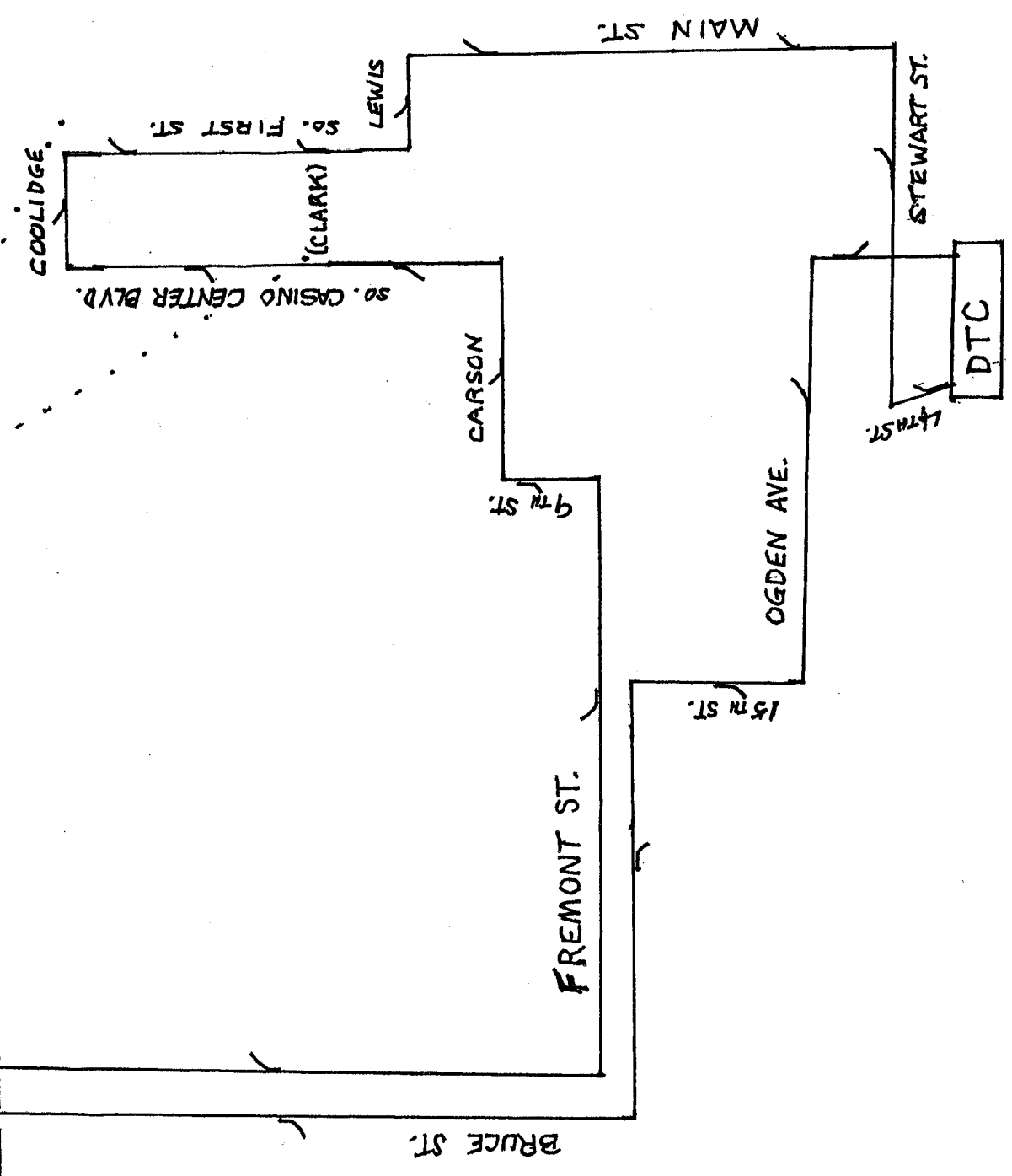
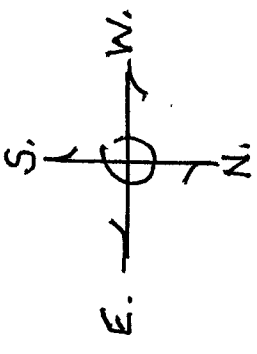
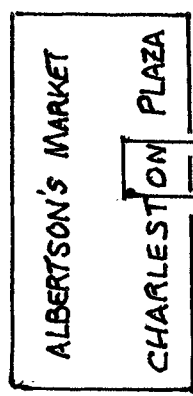
