RE: Objections to a Proposed Variance (VAR-19672) with Applicant TCR Southwest Properties, Inc.

To Whom It May Concern:

We are voicing our objection to a proposed variance from a senior citizens apartment complex named Sonoma Palms to a multi-family development, which is off the southwest corners of Cheyenne and Jones across from our development, The Willows. We are putting our concerns in writing as we will not be able to attend your City Council Meeting in Chambers on June 20th at 1:00pm due to work schedules.

We were told by the City of Las Vegas that these units were for the specific purpose of housing seniors. Changing these units to accommodate anyone was not how this complex was originally presented to our community. As our development only has two entrance/exits, changing this proposed facility from senior apartments to multi-family apartments anyone could rent would also make it very difficult for ingress and egress from our development due to more vehicular traffic from a facility such as this. Let alone the possibility of serious quality of life issues. My wife and I have been a resident in the city of Las Vegas since the early sixties and have been at this location for almost eleven years now. We bought our home in this community because this area didn't have strip shopping or apartments. Furthermore, it is our belief that we have been misrepresented if this complex is changing from the type of facility it was originally presented as to one such as this. These units are almost completed. My question to you is, how can this variance happen during the construction stage? Someone should be accountable, and it shouldn't be the residents of The Willows housing development.

We hope that these two votes against this variance issue are heard loud and clear during your City Council Meeting. Should you wish to discuss this with us further, you may do so by contacting us at the number above. We welcome your feedback regarding this most important issue.
