
Dear Ms. Bridges:

A required two year review for one of Clear Channel's billboards is scheduled for consideration on Wednesday's City Council agenda as Item #75. We respectfully request that this item be held. As you may be aware, a new billboard ordinance has been negotiated, and we expect that it will be introduced for consideration in the near future.

We would like our client's billboards to be reviewed under the standards of the new ordinance. This item was initially scheduled on the June 20, 2007 City Council agenda, and an abeyance was granted for the same reason. We are not seeking an indefinite abeyance but we do not know the exact date the ordinance will be introduced.
