Concerning the abeyance notification I received for a planned compact lot subdivision on the 7 acres bordering Gilmore and El Capitan roads, I must say that I am strongly opposed to this development. The property is zoned for Ranch Estates, R-E, and that is how it should be developed considering the neighborhoods that surround it. When we purchased our house in 1995 from American West, we were told of the zoning for that property. We were also told that two doctors owned it and there was no chance they would sell to anyone who was interested in commercial development or any high density housing. We were led to believe that when it was developed, it would be with custom estates homes and probably as a small gated community.

Apparently, the owners got greedy and they do not care about the homeowners in the surrounding neighborhoods. I would like to ask them how they would like it if a high-density development full of cracker box homes sprung up next to their upscale residences. High-density = higher crime, graffiti, less homeowner pride, renters, or abandoned homes in foreclosure as we see in the news every day.

This type of high-density housing is what investors buy and rent out to low income, transient people. Look around at the surrounding neighborhoods of homes over \$350,000 in value, and you will not see any compact type of housing like you propose. We moved here because we wanted to be in an area where the homes in the surrounding neighborhoods were as nice as ours and our property values would be stable. Until now, that is what has occurred, with very nice neighborhoods in the surrounding area. Having such high-density housing in our back yard will lower our property values (but not our taxes). This will make it more difficult to sell our property in eight years when we retire. Our plans include upgrading our home with energy-efficient, environmentally friendly measures in the spring of next year. It will cost us over \$60,000 to install solar panels, liquid stucco and artificial turf. We are trying to be environmentally conscious, and we had hoped that we would get most of the money back when we sell. However, if the compact housing is in our back yard, I don't think any amount of upgrades will matter, and it could be a waste of money for us to do what is environmentally correct.

I am astonished that the developers are considering 56 homes on seven acres and without even a cul-de-sac turn around! Looking down my street, Sailplane Avenue and counting houses, the number of homes that are proposed is more than double the homes on our street, and our street does not have "huge" lots along the main part of the street, which runs parallel to the 7 acre property behind it. They are just standard 6,000 square foot lots. I cannot imagine how they could put homes on lots half that size. Obviously, they are not concerned with the people in the surrounding neighborhoods or the environmental impact of this high-density, compact home proposal. Are the developers also planning to make this "low income" dwellings and get governmental assistance for developing it this way?

My husband and I hope to attend the meeting, but since we are both teachers and the meeting is on the second day of classes, we may have to watch it on TV. I am writing to you with hopes that you will address some of my concerns at the meeting. Thank you for representing us.

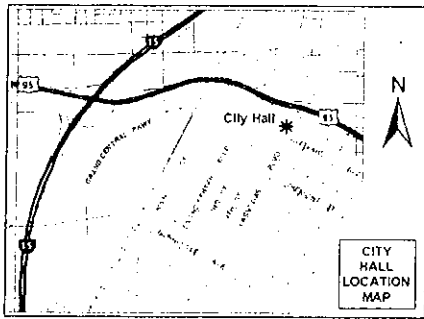

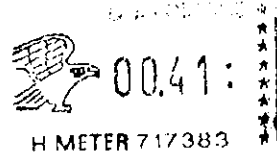

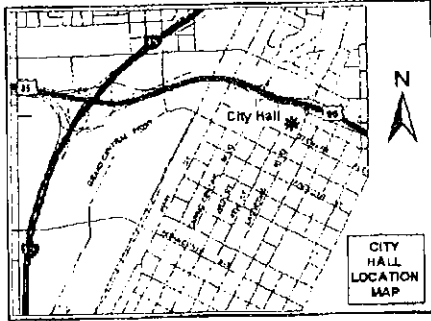
