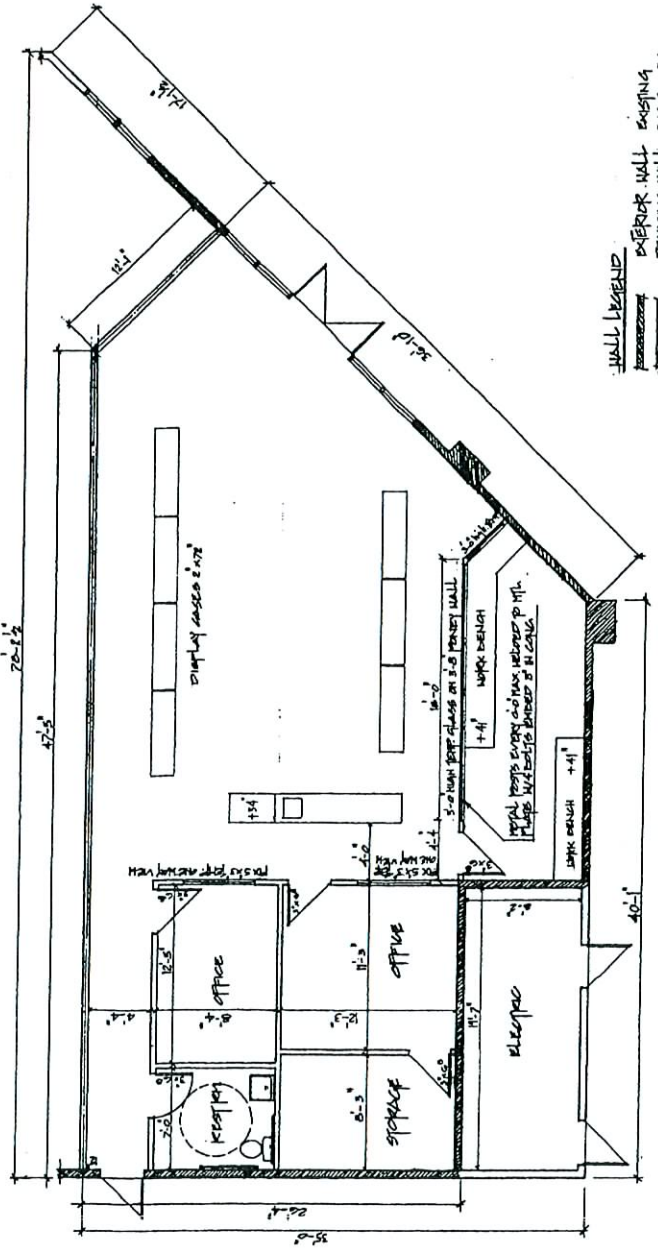

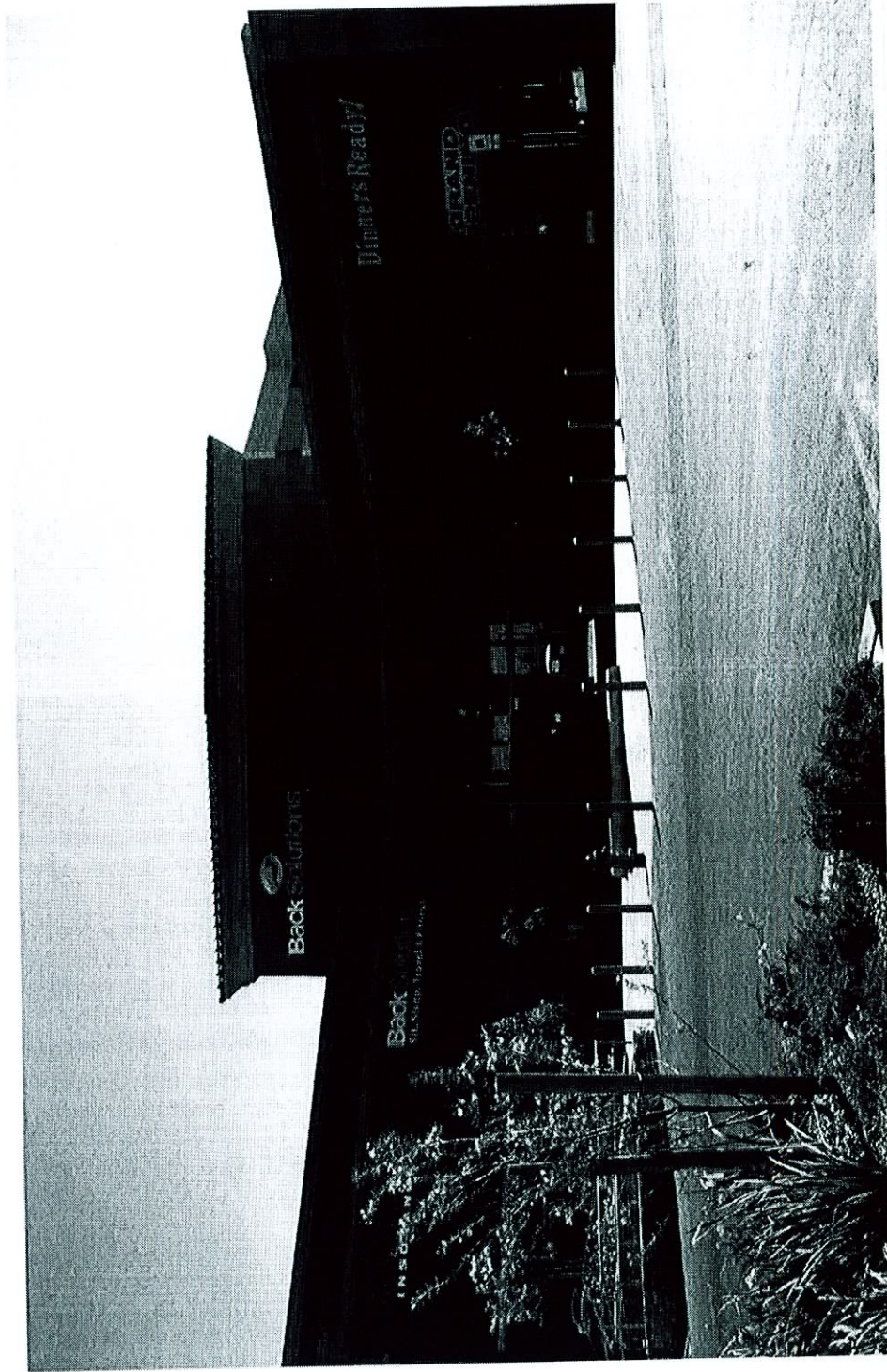
FLOOR PLAN 1/4"=1'-0"

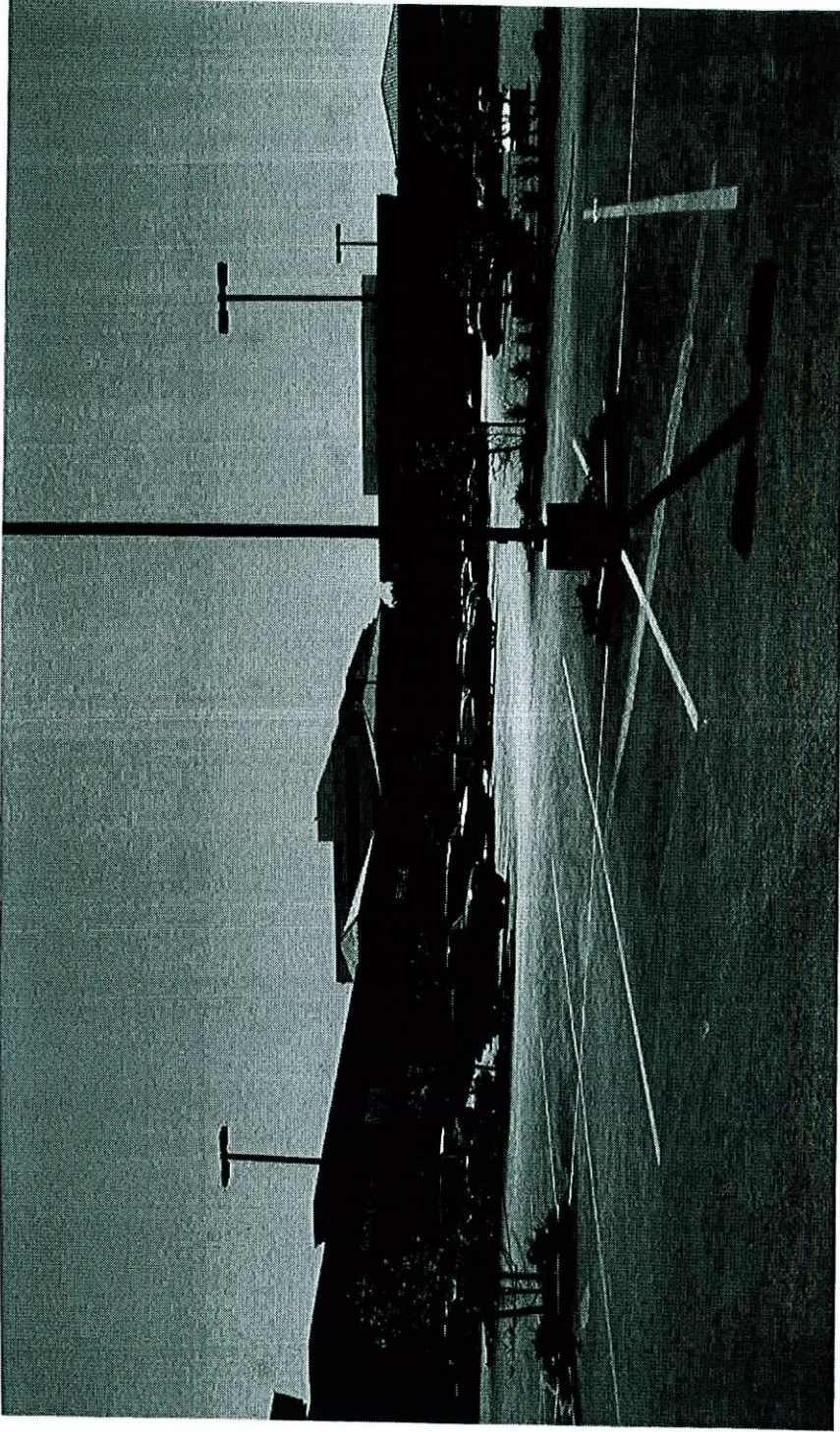
