**PURPOSE/BACKGROUND:**

On February 18, 2004 City Council approved the award of an Engineering Design Services Agreement for Oakey-Meadows Storm Drain and Street Rehabilitation Project to Post Buckley Schuh & Jernigan in the amount of \$2,007,463. The First Amendment represents additional engineering services to include a 70% submittal, utility potholing, a hydro-geological investigation, a geotechnical investigation, Right-of-Way research, coordination with Carter Burgess in the design of the Decatur Boulevard Rehabilitation Project and other related design services not included in the original scope of the project in the amount of \$1,433,102 which brings the total contract amount to \$3,440,565.
