Please let this letter serve as an objection to the above referenced agenda item. As the Westleigh Neighborhood Association President, I feel it is important to bring to the attention of the City Council that many residents in our neighborhood do not wish this request to be approved.


The request is essentially to remove a requirement to return a second dwelling on the property in question from a guesthouse to a storage room if the property is sold. The property owner is claiming an "extreme hardship" if this requirement is not removed. The current property owner purchased the property in December 1992 and claims to not have known about this requirement. It should be noted that mid-September 1992 this issue was brought before the City Council and was denied. We respectfully request that this decision stand.

Concerned neighbors have expressed to me that they absolutely do not want multiple dwellings approved in our single dwelling neighborhood. The Westleigh Neighborhood was developed in the early 1950's and many homeowners are interested in preserving the historic qualities of our neighborhood. Allowing a second dwelling to remain simply because it has done so for so long is not consistent with the make up of the neighborhood. We are also concerned of the precedent that may be set, as we are aware of other homeowners who are illegally trying to do similar things.

Of further concern, is the fact that several residents indicated at our last Westleigh Neighborhood Association meeting that they did not receive notice of this request, although city records indicate 272 notices were sent. I can attest that as President of the Westleigh Neighborhood Association, I was not given notice of this and only became aware of the issue when a couple of concerned neighbors brought it to my attention. This is very concerning as a great deal of personal time and commitment by interested residents has gone into reactivating our neighborhood association.

Thank you for your consideration of our request to deny this variance request.
