PURPOSE/BACKGROUND:

This proposed contract amendment increases the project scope for design of a new alignment of the Oakey Meadows Storm Drain. On February 18, 2004 City Council approved the award of an Engineering Design Services Agreement for Oakey Meadows Storm Drain and Street Rehabilitation Project to PBS&J in the amount of \$2,007,463. The First Amendment represents additional geotechnical investigation, right-of-way research, adjacent project coordination and other related design services not included in the original scope of the project in the amount of \$2,353,654 which brings the total amount to \$4,361,117. Funding for this Amendment comes from the Regional Flood Control District.
