**PURPOSE/BACKGROUND:**

Discussion and possible action regarding Temporary Approval of a new Psychic Art and Science License.

Motion made by GARY REESE to Approve the temporary license, with the Director or Designee granted the authority to approve the permanent license after completion of appropriate process or extend the temporary license in the event the police report is not completed within the six-month temporary period, and the following conditions:

- A. Rates must be conspicuously posted on a sign of at least 8 x 10 with letters no smaller than one inch.
- B. If the licensee operates by donation or indirect method of payment, including discretionary remuneration, the signage shall also disclose it to the patron.
- C. The rates published shall be the only rates charged.
- D. The temporary license shall be reviewed in 90 days.

Minutes:

JIM DiFIORE, Manager of Business Services, said there were no initial concerns with the applicant, who was present. MS. ADAMS would be working with LORRAINE MARKS, who was approved several months ago with several conditions. He suggested approval with the same conditions imposed on MS. MARKS, and enumerated those conditions.

COUNCILMAN REESE referred to an informational packet, of which he submitted a copy for the minutes. He also mentioned that he met with the applicant's husband, and he feels uncomfortable with him. Hence, he conferred with MR. DiFIORE, MRS. ADAMS and MS. MARKS that the applicant's husband would not have any involvement in the business.
