Mayor nominates 2 persons for appointment residing in 2 different Wards  
Each Councilmember nominates 1 person for appointment (Persons nominated must reside in Ward represented by Councilmember making nomination)

**TERM:** Serve for an uninterrupted period not longer than eight years (2 terms) (Term to be coterminous with City Councilmember, but may serve until a successor is appointed)

**NOTES:** Must be a City Resident
