CITY COUNCIL MEETING OF: September 5, 2007

MAYOR GOODMAN declared the Public Hearing open.

EDGAR PATINO, 6226 West Sahara, and SCOTT ROONEY, were present. MR. PATINO outlined the three primary changes; first the addition of a transmission line that begins at the northwest substation. The second change would be the removal of a previously approved substation at the intersection of Tropical Parkway and Hualapai Way. The third proposed change would be the addition of a proposed substation site north of Centennial and east of Hualapai Way. The current substation is located within the City of Las Vegas, and the proposed transmission line is located both within the County and City of Las Vegas.

MR. PATINO also indicated that staff was concerned with the specific location of the transmission poles along Centennial interfering with existing and planned roadways and/or left-hand, right-hand turning packets. However, he committed that Nevada Power will coordinate with the City of Las Vegas and Clark County School District on the locations of future poles. He also agreed to all conditions.

MAYOR GOODMAN declared the Public Hearing closed.
