## REDEVELOPMENT AGENCY MEETING OF: SEPTEMBER 5, 2007

### Minutes:

SCOTT ADAMS, Operations Officer for the Redevelopment Agency, stated that Redevelopment Agency Items 5 and 6 are related to City Council Item 69, and their approval is contingent upon approval of City Council Item 69. The three items involve a CVIP agreement regarding improvements to a wedding chapel. Before pictures of the site and a sketch of the chapel were shown. MR. ADAMS noted that the \$50,000 will go toward exterior improvements. Staff recommended approval.

CLIFF and SUSANNE EVERETS were present. MR. EVERETS said he and his wife want to build the first world-class wedding chapel to attract more people and high-end weddings. MEMBER REESE commented that this chapel will make a big difference in the redevelopment area.
