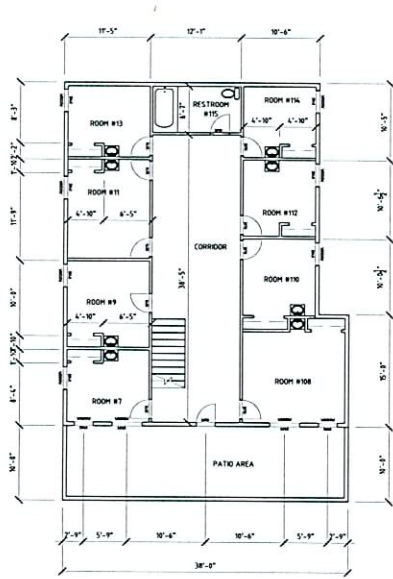

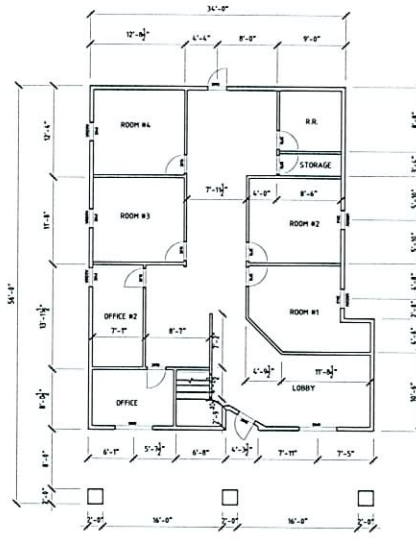

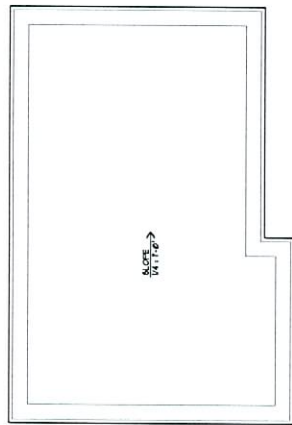




2 2ND FLOOR PLAN SHEET
