PURPOSE/BACKGROUND:

On May 5, 2004 City Council approved the award of an Engineering Design Services Agreement for Lone Mountain Lift Station to Carollo Engineers in the amount of \$299,937 and on March 2, 2005 Council approved the First Amendment in the amount of \$49,979 for additional engineering services including modifications to HVAC, Pump Room, and the addition of an Electrical Room. On August 17, 2007 the Purchasing Manager approved the Second Amendment in the amount of \$24,222 to include the evaluation and review of blowers at the Equalization Basins at the Durango Hills Water Resource Center. The Third Amendment includes assembly operations, maintenance manuals and training in the operations and maintenance of the Lift Station in the amount of \$50,000, bringing the total Agreement amount to \$424,138.
