**PURPOSE/BACKGROUND:**

On July 2, 2003 City Council approved the award of an Engineering Design Services Agreement for Martin Luther King Boulevard Widening - Alta Drive to Carey Avenue to VTN Nevada in the amount of \$940,000 and on April 26, 2006 Council approved the First Amendment in the amount of \$500,000. The Second Amendment includes additional engineering design services for modifications and relocation of Las Vegas Valley Water District (LVVWD) facilities, right-of-way revisions, legal descriptions, bus turn-out modifications and Nevada Power Company and Nevada Department of Transportation coordination, construction services, an agreement providing for public outreach services and public information assistance, and additional related services. Funding is provided by the Regional Transportation Commission of Southern Nevada.
