


# Kyle Canyon Casino Site

## PROPOSED General Plan Designations



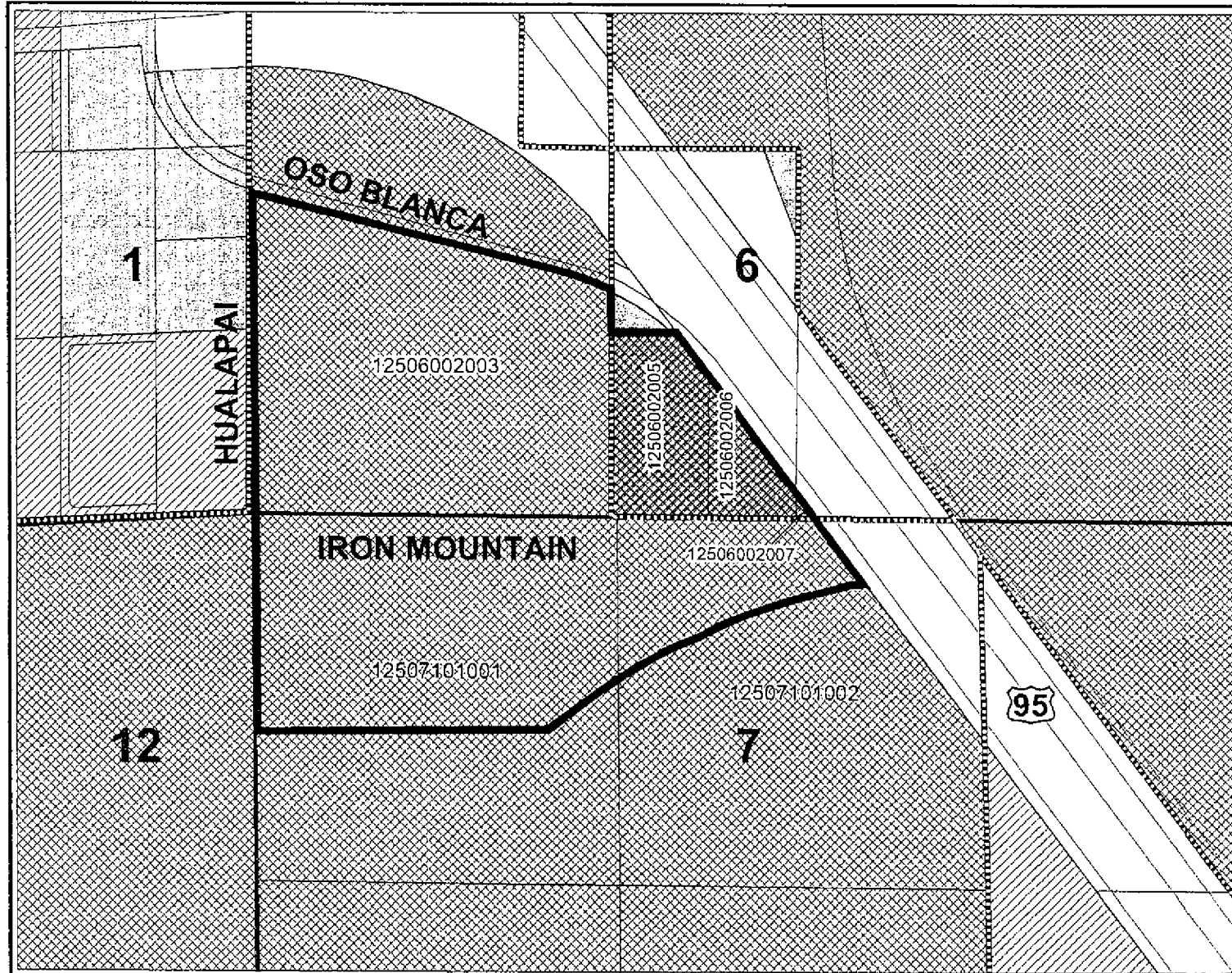
-  Parcels subject to General Plan Amendment to Traditional Neighborhood District

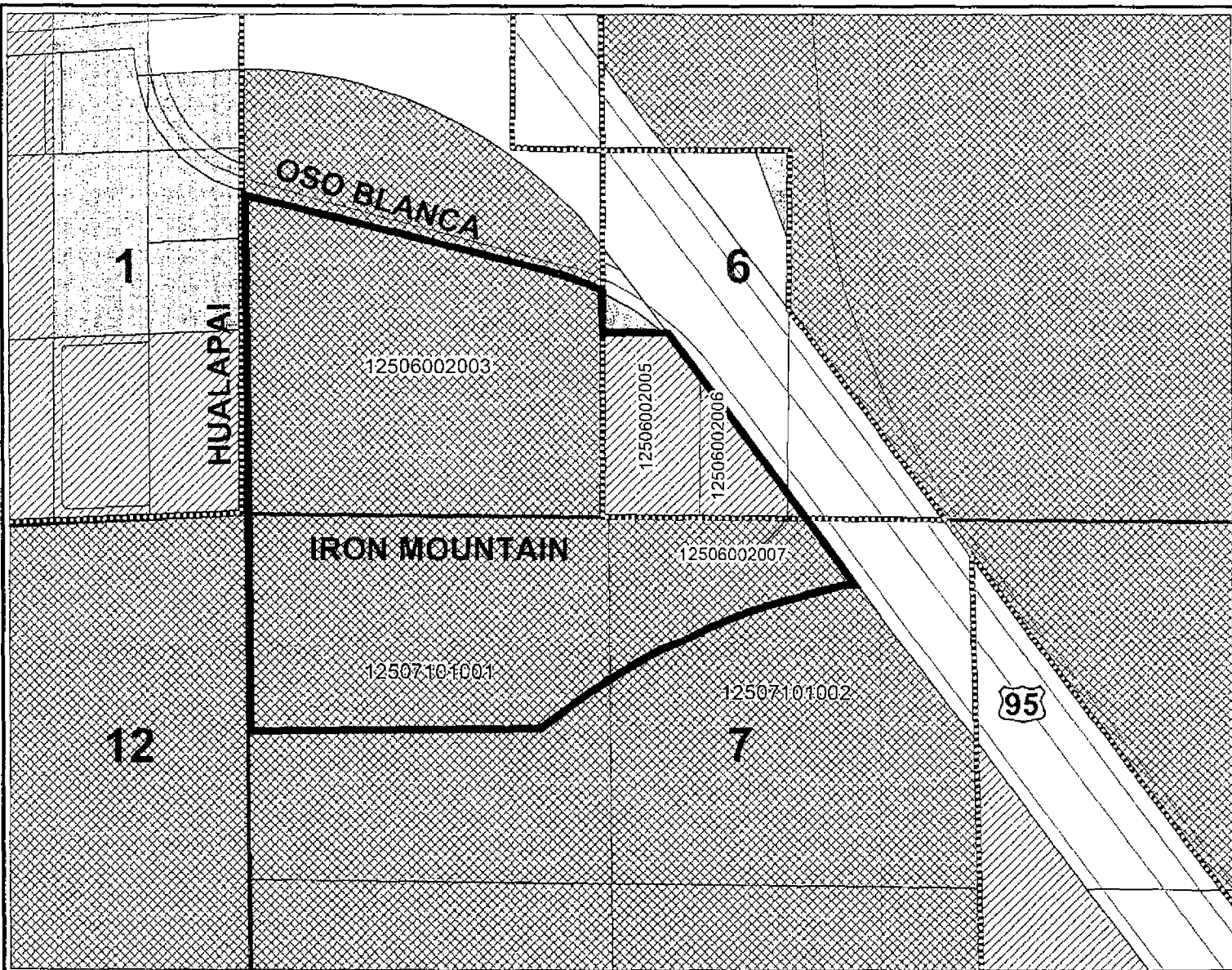
