Construction shall commence within 30 days of approval of such civil plans by the City and shall be completed within 120 days of commencement of construction or by July 12, 2008, whichever occurs first. Failure to comply with this requirement shall result in this item being reconsidered by City Council.

B. This approval is subject to review at the December 19, 2007 City Council meeting to demonstrate compliance with all conditions of approval and meeting City codes.
