ACTING CHAIRMAN GOYNES declared the Public Hearing open.

PLANNING COMMISSION MEETING OF: DECEMBER 20, 2007

This item was under the One Motion/One Vote portion of the agenda and was pulled at COMMISSIONER EVANS' request.

ANDY REED, Planning and Development Department, stated the application is in conformance with the pattern of development in the area and recommended approval.

QUAN PHAM was present.

TODD FARLOW, 240 North 19th Street, requested the site development plan be displayed and questioned the need for the landscape waiver.

COMMISSIONER EVANS expressed concern with the landscaping and lighting of the project because similar projects had negatively impacted the area. He encouraged the applicant to install and maintain attractive landscaping on the site.

MARGO WHEELER, Director of the Planning and Development Department, informed COMMISSIONER EVANS that an inspection team visits various properties to ensure the conditions of approval are met. If sites are found to be in violation, they are reported to Code Enforcement.

MR. PHAM explained that his current landlord was not maintaining the landscaping at his current location and stressed the importance of a great image for attracting a great clientele. COMMISSIONER EVANS thanked Mr. PHAM for his comments and expressed his confidence in staff's ability to work with Mr. PHAM to ensure the landscaping is attractive.

MR. PHAM explained that the parking lot could only accommodate four vehicle and was the reason for the landscape waiver request.

ACTING CHAIRMAN GUYNES declared the Public Hearing closed.
