On July 11, 2007 Council approved a Purchase Agreement for this land for a future park and trailhead facility. This project has been selected to be funded by the Question 1 Grant Program in an amount not to exceed \$2,150,000. The receipt of funding is contingent upon successful execution of a State Lands Funding Agreement and review by Fiscal Services of the Department of Conservation and Natural Resources.
