Minutes:

MAYOR GOODMAN declared the Public Hearing for Item 83 open under Item 82.

LENI SKAAR, 3753 Howard Hughes Parkway, appeared on behalf of the applicant. At COUNCILWOMAN TARKANIAN'S request, she explained that the Planning Commissioners were concerned about the storage location of the 10 rental vehicles. As a result, the location has been moved to the southernmost lot, Green Lot 17, which is an area that is seldom used. She used a map to indicate where the lot was located.

COUNCILMAN REESE verified with COUNCILWOMAN TARKANIAN that the applicant will be allowed to use 10 spaces, as the subject lot area is used very little.

MARGO WHEELER, Director of Planning and Development, added that Condition 5 would need an amendment to reflect seven aisles and not three. In addition, she confirmed that staff has the current plan. MS. SKAAR spoke of ASSISTANT CITY ATTORNEY BRYAN SCOTT asked that the plan be submitted for the record.

MAYOR GOODMAN declared the Public Hearing for Item 83 closed under Item 82.
