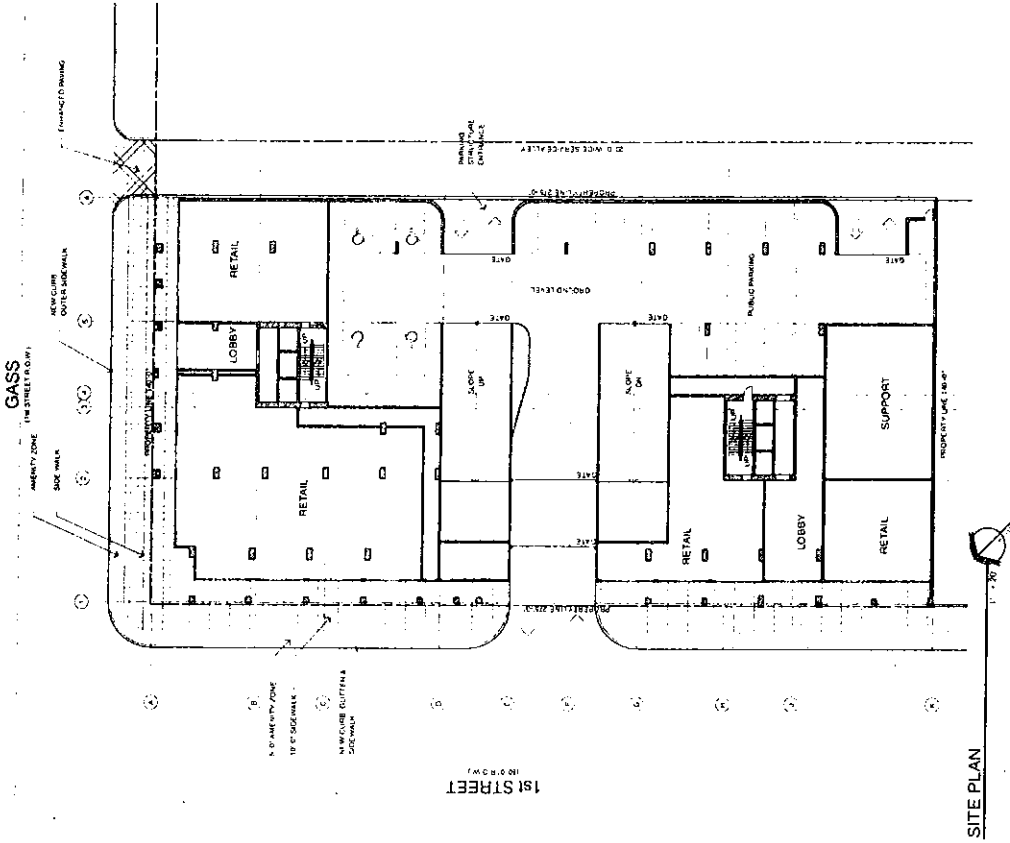


VICINITY & LOCATION MAPS
