
RE: Variance V-0154-94: 90 foot tall billboard.

Dear City Council:

Of behalf of NFC, LLC, the owner of the office building located at 2300 West Sahara, immediately west of the subject off-premise billboard, I respectfully submit this letter of opposition to the approval of Variance V-0154-94.

The signage in question is 90 feet in height and not compatible with the mixed use nature of this residential/commercial neighborhood. While we question the wisdom of having any billboard signage on this property, certainly a standard billboard height of 55 feet would be sufficient and more in keeping with the City's policy on advertising in a mixed residential/commercial neighborhood. Over the past several years the City of Las Vegas has taken steps to improve the view corridors in neighborhoods by eliminating or restricting the height and size of commercial billboards. This sign deserves the same attention and restrictions.
