This is a letter supporting Annie and Dean Mallet's petition for a Special Use Permit / Zoning Variance to allow a change from a 1-6 to a 7-12 children child care license. Especially because the increase is needed to accomodate additional younger siblings of children currently in her care.)

I have been their immediate next door neighbor (east side) for over nine and a half years. In the spring of 2003, they approached me about starting a child care facility in their home.
