REDEVELOPMENT AGENCY MEETING OF: NOVEMBER 21, 2007

Minutes:

SCOTT ADAMS, Operations Officer of the Redevelopment Agency, gave a brief history of the item. He displayed before and after pictures.

At the request of MEMBER REESE, DICK BONAR, appearing on behalf of the applicant, displayed new renderings, noting that the neon component was increased. Additionally, a pylon sign was added in the parking lot with animated light around the OG circle.

MEMBER REESE indicated that the applicant increased the neon well above the requirement. He felt very strongly about neon, especially in the Entertainment District. It is important to show that the City is making neon more visible, even on Las Vegas Boulevard. He appreciated the applicant working with him on this and expressed his support for this sign.
