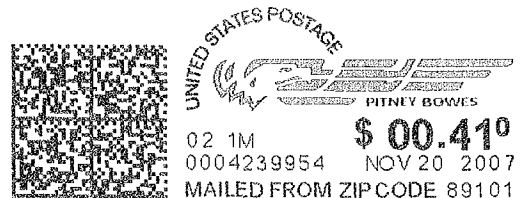
# Protest

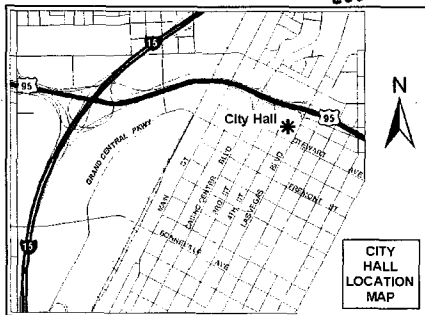
