Approval of a new Tavern License, a new Restricted Gaming License for 10 slots, and a new Class III-C Secondhand Dealer License.

- A. The tavern and gaming licenses shall be non-transferable.
- B. Alcohol sales shall be limited to the hours of operation of the Las Vegas Gun Club, which presently are Wednesday, 9:00 a.m. to 10:00 p.m. and Sunday through Thursday, 9:00 a.m. to 5:00 p.m. This will include the addition of Tuesday, 9:00 a.m. to 5:00 p.m. during the months of March through May and September through December.
- C. Gaming will be limited to ten slot devices unless approved by the City Council up to the maximum of 15 slot devices.
- D. Advertising of the sale of specific brands of alcoholic beverages, by any means, visible from the exterior of the concession is not permitted.
- E. The sale or purchase of hand guns shall not be permitted.

F. The licensee must maintain compliance with all provisions of the existing lease concession contract for Floyd Lamb State Park.

G. The license is to expire at the end of the lease period December 31, 2008 unless an extension of time is approved by the City Council.

H. The licensee will be allowed to receive gun transfers from members who have purchased guns elsewhere.

Minutes:

The applicants were present.

JIM DiFIORE, Manager of Business Services, read and recommended some conditions that he had discussed with the applicants. A) The Tavern and gaming licenses shall be non-transferable; B) Alcohol sales shall be limited to the hours of operation of the Las Vegas Gun Club, which presently are Wednesday, 9:00 a.m. to 5:00 p.m. and Sunday through Thursday, 9:00 a.m. to 5:00 p.m. This will include the addition of Tuesday, 9:00 a.m. to 5:00 p.m. during the months of March through May and September through December; C) Gaming will be limited to ten slot devices unless approved by the City Council up to the maximum of 15 slot devices; D) Advertising of the sale of specific brands of alcoholic beverages, by any means, visible from the exterior of the concession is not permitted; E) The sale or purchase of hand guns shall not be permitted; F) The licensee must maintain compliance with all provisions of the existing lease concession contract for Floyd Lamb State Park, G) The license is to expire at the end of the lease period December 31, 2008 unless an extension of time is approved by the City Council, and H) The licensee will be allowed to receive gun transfers from members who have purchased guns elsewhere.

MR. CARMICHAEL indicated that he has never stocked, purchased or sold handguns, but he has allowed members to purchase elsewhere and transfer them in on his FFL, and he would like to be able to continue this service, as well as to open for Tuesday, with the same privileges and hours of operation.

Regarding the lease agreement, COUNCILMAN REESE confirmed with MR. DiFIORE that it is through the State of Nevada, assigned to the City of Las Vegas. He then asked MR. DiFIORE if the payments were current, to which MARK VINCENT, Director of Finance and Business Services, replied that the payments are set up on a quarterly basis and due in advance, but there were outstanding invoices from the 10th of November. COUNCILMAN REESE then directed MR. DiFIORE to brief him on the lease and the status of the payments. COUNCILMAN ROSS requested that every member of the Council be briefed.

MR. CARMICHAEL concurred with the conditions, adding that at the end of the lease, tenancy would be set up on a month-to-month basis. COUNCILMAN ROSS commented that he would be happy to meet with him to discuss the plans and to help facilitate the transition.
