PURPOSE/BACKGROUND:

This project consists of the rehabilitation of approximately 6,050 linear feet of 21-inch diameter pipe in Lone Mountain Drive and Rancho Drive and approximately 170 linear feet of 15-inch diameter pipe in Rancho Drive and Craig Road. In addition, this project includes the incorporation of the Craig Road Relief Sewer. A control manhole for this relief sewer will be installed along the existing 21-inch sanitary sewer in Rancho Drive. Also, approximately 622 linear feet of 15-inch sanitary sewer in Decatur Boulevard between Alta Drive and Mayflower Lane will be rehabilitated.
