PLANNING COMMISSION MEETING OF: JANUARY 24, 2008

Subsequent to the motion to hold in abeyance Items 47 and 48 to 2/14/2008, DEPUTY CITY ATTORNEY JAMES LEWIS was approached by a member of the public who asked to speak on these items.

After a discussion among COMMISSIONER TRUESDELL, COMMISSIONER EVANS, DEPUTY CITY ATTORNEY LEWIS and DOUG RANNEY, Planning and Development Department, regarding the appropriateness of taking public comment on these items, CHAIRMAN GOYNES allowed CHRISTOPHER ODLE, 10773 Pockermans Avenue, to speak and noted that his comment would be incorporated into the record.

MR. ODLE appeared on behalf of his neighbors and expressed their opposition to both applications. He explained they would like the land use to remain unchanged.

MARGO WHEELER, Director of the Planning and Development Department, stated she had attended the neighborhood meeting where it was announced that the items would be abeyed.
