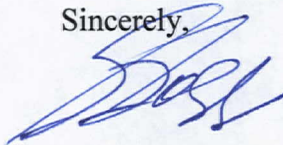
Re: Variance for Shed at 612 Ordrich Place

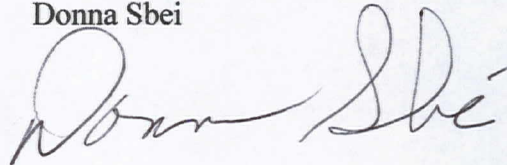
Dear Madam or Sir:

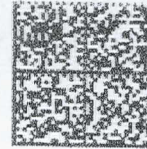
I have no problem with the shed or its placement. I actually like it because it cuts down the wind that blows into my backyard. I support the variance.

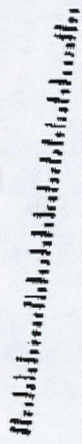
