My name is Dedra Geran and reside at 1216 North "I" Street and a life long resident of the area in question. Speaking on behalf of other residents in this area WE OPPOSE the applicant request to go from a medium density residential to high density residential. Based on crime statistics in this area it will be a disaster in the making.

I know first hand what is like to live in this neighborhood. I was born and raised in this neighborhood. This will be the third time around for housing on this site. The first Madison Terrace low-income housing closed after a series of crime and neglect. City rebuilds it, moved all of Herbert Gerson Park residents in it to become Emerald Breeze. Closed it again due to crime and neglect after 15 years. Now you want to try it again. You will move all of Buena Vista into this area no doubt. I don't have 15 more years to live in fear, to leave work during the day to see if my house has been broken into.

4 stories are too many, I would settle for two stories like the complex next door to it. But why in this neighborhood? Their other projects have not included 4 story buildings. They brought up to us that the construction would increase our property value. If it were that great they would be building it in their own neighborhoods.

They say they will control the inside of the complex with parking rules and such by can not control the outside. Now it becomes my problem when cars are parked two three deep partial parking my drive way and sometimes blocking it with no regard to the homeowners while they run buy drugs. When you bring to the apartment management attention they laugh you away and say see the city, as long as they are not violating their premises. We got the same promises from the city when they refurbished Madison Terrace. Again lies.

Since the closure of Emerald Breeze my night's sleep has been very peaceful. No sirens or helicopters during the night, no boom boom boom music playing and most of all no gun shootings.

I once over heard two police cruisers one night and one officer commented that his night shift wasn't so bad since they boarded up the Emerald Breeze Apartments.

Crime statistics show that in the past Monroe Ave is a haven for stolen cars. It was so bad at one time; I had the cell phone number of a Findley Car Representative to contact. Why should we go through this again?

They show on the paper and advertise an 82 Unit Apartments. That does not include the 32 units of existing buildings and the future proposed building. How many units total will it be times the number of occupants in each unit? TOO MANY! Again lies.

The current enrollment at Wendell Williams School is well above average and on the brink of overcrowding. These 82 units plus will now make the school over crowded which means again non performance in our schools in low income areas because of classroom over crowding.

I'm afraid that 4 story units where people rely on elevator use, kids playing in them, little girls or boys being molested. 4 flights is a long way up pushing the stop button before help arrives compared to two flights.

I'm afraid of the balconies being that high up that a little child will fall off. They say the balcony will be out of the reach of a child, but if that child happens to climb on a chair and jump off then that is their problem. WHAT!

I am also afraid this will be the start of a Chicago disaster version of aRobert Taylor housing project.

I actually love the way the neighborhood is now, less stress on the neighbors, people actually come outside and sit for a while, they speak and walkers stop and talk to you. We all comment how peaceful it is.

This complex will surround a block that is sparsely populated. Ivy Lane is one block long, Cunningham Drive is two blocks long and "I" Street is 3 blocks in which one block only houses 3 homes and the remaining blocks only have homes on one side of the street and the school on the other.

Kids at the school are well mannered; their parents walk them to and from school. The kids that lived in Madison Terrace and Emerald Breeze walked to school alone when they were forced to attend. No kids opening your mailboxes.

We like it like that and want to keep it like that, NO to four stories and no to entrances or exits on Monroe Ave. Vote NO NO NO 7 seven times NO.

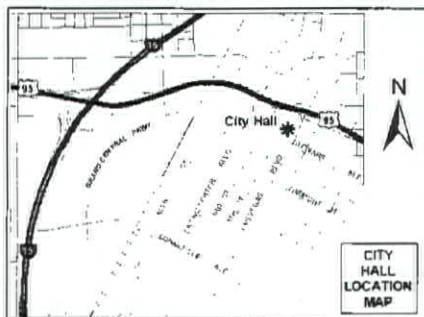
