As owner of 1821 Western, I approve of Tim O'Rourke's request for this variance.

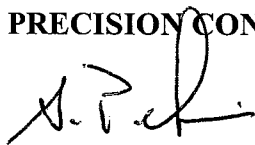


Dear Commissioner,

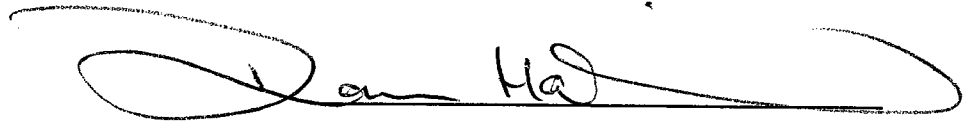

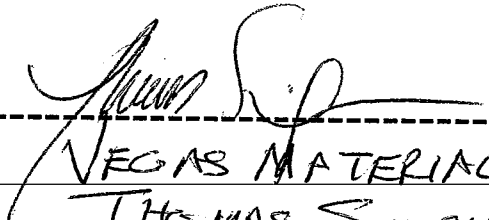

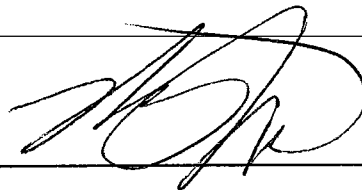
