Under Item 72, COUNCILMAN BARLOW requested that Items 112 and 113 be taken off the abeyance list for discussion.

COUNCILMAN BARLOW thanked MR. RUSSELL for his comments and agreed with him on his opinion of the church.

The Councilman acknowledged his support for the subdivision of the parcel but asked for the removal of the condition regarding Bruce Street and 3000. BART ANDERSON replied that Condition of Item 113 suffices, and the approval of Item 112 would allow them to go forward without the cul-de-sac.
