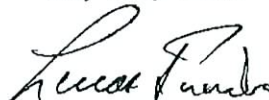
Dear Ms. Burney,

Lionel Sawyer & Collins represents Clear Channel Outdoor. A required five year review for one of Clear Channel's billboards is scheduled for consideration on Thursday's Planning Commission agenda as Item #46. We respectfully request that this item be held. The prior approval of this billboard was subject to a condition regarding a final inspection and building permit. Clear Channel has commenced the process of applying for a review of that condition, to allow Clear Channel to satisfy the condition by obtaining a letter of certification from an engineer in lieu of a final inspection. A request for a pre-application conference has already been submitted to initiate the application process for reviewing that condition.

Accordingly, we respectfully request an abeyance of item #46 until the Planning Commission meeting scheduled for May 8, 2008. This will allow the regularly scheduled five-year review to be considered at the same time as the application for review of the condition discussed above.

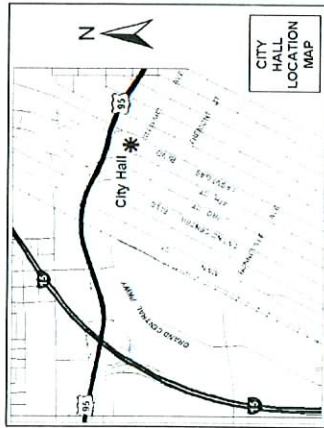
