Dear Ms. Eylar:

The City Council at a regular meeting held December 21, 2005 APPROVED the request for a Special Use Permit FOR A SUPPER CLUB AND A WAIVER OF THE 400 FOOT DISTANCE SEPARATION REQUIREMENT FROM AN EXISTING CHURCH adjacent to the southwest corner of Tule Springs Road and Farm Road (APNs 125-17-702-003, 004, and 005), T-C (Town Center) Zone. The Notice of Final Action was filed with the Las Vegas City Clerk on December 21, 2005. This approval is subject to:

Planning and Development

1. Conformance to all Minimum Requirements under Title 19.04.050 for Supper Clubs.
2. Approval of and conformance to the Conditions of Approval for and Site Development Plan Review (SDR-5948) and Variance (VAR-7655).
3. This Special Use Permit shall expire two years from the date of final approval, unless it is exercised or an Extension of Time is granted by the City of Las Vegas.
4. Approval of this Special Use Permit does not constitute approval of a liquor license.
5. This business shall operate in conformance to Chapter 6.50 of the City of Las Vegas Municipal Code.
