**** STAFF REPORT ****

PROJECT DESCRIPTION

This application is a request for an Extension of Time of an approved Special Use Permit (SUP-10459) for General Business-related Gaming Establishment within an existing Car Wash. The proposed use is located at 4450 East Washington Avenue.

A previous Extension of Time (EOT-19572) was approved by the City Council for a one-year approval from the original approval date that expired 12/15/07. Since that time the applicant has not made any substantial progress toward obtaining a Business License for the approved use at this time. The existing facility currently supports a Car Wash and some minor retail uses; the proposed General Business-related Gaming Establishment requires that the applicant secure an approved business license within a one-year time frame from the most recent approval in order to exercise the Special Use Permit entitlement.

Staff recommends a one-year extension of time in order for the applicant to obtain the appropriate business license.

ANALYSIS

This is the second Extension of Time request for the approved Special Use Permit (SUP-10459) the proposed General Business-Related Gaming Establishment use within an existing Car Wash. The applicant has not made any progress towards securing a business license for the proposed use. The approved Special Use Permit (SUP-10459) would be exercised upon the issuance of a business license for a General Business-Related Gaming Establishment by no-later-than 2/15/09. Staff finds that a one-year Extension of Time is appropriate for the applicant to secure the approved entitlements.

FINDINGS

It is important to note that the approved Special Use Permit (SUP-10459) was required to conform to the conditions of approval for Site Development Plan Review Z-0105(1) and Special Use Permit U-0115-99. In particular, the current landscaping is deficient from the approved landscape plans depicted on the Landscape Plans provided with Site Development Plan Review Z-0105(1). Staff recommends approval of a one-year Extension of Time in order for the applicant to complete the development in accordance with the previous approvals and to secure the required business license.
