

FIRST AMENDMENT TO THE INTERLOCAL CONTRACT FOR INMATE HOUSING

THIS AMENDMENT, made and entered into by and between the City of Las Vegas (LAS VEGAS), a municipal corporation of the State of Nevada and the County of Clark (COUNTY), a political subdivision of the State of Nevada, amends the May 1, 2005 inmate housing services interlocal contract and shall be effective upon adoption by LAS VEGAS and the COUNTY.

WITNESSETH:

WHEREAS, the parties hereto entered into an interlocal contract effective May 1, 2005, to provide Las Vegas remuneration for housing County inmates in it's facility; and

WHEREAS, the County's need for additional jail facilities to house inmates will continue for an indefinite period; and

WHEREAS, Las Vegas has the capacity to provide additional jail housing for Clark County inmates;

NOW, THEREFORE, the parties agree to amend the 2005 agreement, as follows:

1. Section 3. Payment by CLARK COUNTY, Paragraph A shall be amended to reflect the negotiated daily rate of \$96.96 effective July 1, 2007.
2. Section 3. Payment by CLARK COUNTY, Add new paragraph D.:

The annual increase in compensation on July 1, 2008, and each subsequent July 1st that this Agreement is in force, will be calculated using the Department of Labor's Consumer Price Index for All Urban Consumers, U.S. City Average, not seasonally adjusted, for the preceding year (i.e. the

increase which will take effect July 1, 2008 will be calculated using the Department of Labor's Consumer Price Index for All Urban Consumers, U.S. City Average, not seasonally adjusted, from January 1, 2007 through January 1, 2008). The resultant percentage increase shall be multiplied by the current daily rate.


3. Section 7. Terms of Contract, the term of the contract will be extended three years, expiring April 30, 2011. Either party may request Section 3 (Payment by CLARK COUNTY) of this Contract to be open to negotiation by providing the other party hereto thirty (30) days written notice. Either party may terminate this Contract by providing the other party hereto thirty (30) days written notice.






