PURPOSE/BACKGROUND:

On July 18, 2007 City Council approved the award of Ordering Agreement No. 070411-DK in the amount of \$1,000,000 for services to thermally treat non-hazardous contaminated soil in support of City Parkway V development activities located at the Union Park area. Modification No. 1 increases the contract amount by \$398,750 for additional services as development activities have increased. Funding is provided by general obligation variable rate bonds. This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(a), Items which may only be contracted from a sole source.
