**PURPOSE/BACKGROUND:**

This Agreement provides for engineering design services for phase 2 of the Las Vegas Wash Trail system. The design is for a pedestrian trail along the Wash between Stewart Avenue and Charleston Boulevard. The scope of work also includes preparation of hydraulic analyses for the proposed channel improvements along the Wash. Funding for this project is provided by the Southern Nevada Public Land Management Act (SNPLMA). This item is exempt from the competitive bidding process pursuant to NRS 332.115.1(b), Professional Services.
