Facsimile and email copies will not be accepted.

Before funding consideration will be given for a successive year, a final report for the previous years' activities must be submitted no later than Monday, October 20, 2008. Additional reports may be requested by the Foundation on a case-by-case basis. *Late reports will result in no further funding from the Nevada Law Foundation.*

Please also note that the Foundation was able to disburse grants more numerous and more substantially this year. However, as you know, the grants distributed by the Nevada Law Foundation are dependent upon interest rates, which continuously fluctuate. Please ensure that your organization maintains an attitude of fiscal responsibility, as this year's grants may not be reflective of future grants.
