Pursuant to Section 302 of the Uniform Code for the Abatement of Dangerous Buildings adopted as Section 16.08.010 of the Las Vegas Municipal Code and Title 9, Chapter 4 of the Las Vegas Municipal Code. NOTICE IS HEREBY GIVEN THAT ON **Wednesday, February 6, 2008**, at the hour of **9:00 A.M.** in the Council Chambers, City Hall Complex, 400 Stewart Avenue, Las Vegas, Nevada, the City Council will consider the following **REPORT OF EXPENSES** submitted by the Director of Neighborhood Services incurred by the City of Las Vegas for:

Abatement of the property by boarding and securing the structure (including all accessory structures), painting all boards the same color as the structure, removing refuse, waste, trash, debris (including clothing, plastic, paper, cardboard, etc), removing the boat, vegetation (high/dry/dead), and posting No Vehicles, No Trespassing and No Dumping signs on property located at **1389 LAWRY AVENUE**, legally described as **VEGAS HGTS TRACT UNIT #4, PLAT BOOK 1 PAGE 77 PT LOT 57D & LOT 58F**. Owner of record at time of abatement: **NEW CENTURY HOME EQUITY LOAN TR, BANK DEUTSCHE NATIONAL TR CO TRS - WARD 5 (BARLOW)**

The Director of Neighborhood Services certifies in the report that the sum of \$3,946.85 was expended (\$2,299.00 for cleaning of the property by C.H. Construction, LLC; \$528.00 for Re-inspection fees (w/late fees); \$325.00 for boarded building certificate fee; \$344.85 Administrative Processing Fee and \$450.00 in civil penalties).

If upon hearing the report, the City Council is satisfied with the correctness of the expenses incurred by the City, it may order a lien of assessment recorded and given to the County Treasurer to be collected in the same manner as ordinary property taxes.

Any person interested in or affected by the proposed charge may file written protests or objections with the City Clerk at any time prior to the time set for the hearing on the Report of Expenses. Each such protest or objection must contain a description of the property in which the signer thereof is interested and the grounds of such protest or objection. The City Clerk shall endorse on every such protest or objection the date it was received by her. She shall present such protests or objections to the City Council at the time set for the hearing, and no other protests or objections shall be considered.
