3 AN ORDINANCE TO ADOPT THAT CERTAIN DEVELOPMENT AGREEMENT ENTITLED
4 "DEVELOPMENT AGREEMENT BETWEEN THE CITY OF LAS VEGAS AND THE BOARD
5 OF REGENTS OF THE NEVADA SYSTEM OF HIGHER EDUCATION ON BEHALF OF THE
6 COLLEGE OF SOUTHERN NEVADA," AND TO PROVIDE FOR OTHER RELATED MATTERS.

Summary: Adopts development agreement with
7 the Board of Regents of the Nevada System of
8 Higher Education, on behalf of the College of
9 Southern Nevada, regarding property located in
the vicinity of Durango Drive and Oso Blanca
Road.

10 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
11 AS FOLLOWS:

12 SECTION 1: That certain development agreement entitled "Development Agreement
13 Between the City of Las Vegas and the Board of Regents of the Nevada System of Higher Education
14 on Behalf of the College of Southern Nevada," which was approved by the City Council on February
15 6, 2008, and which is on file with the City Clerk's Office, is hereby adopted in conformance with the
16 provisions of NRS Chapter 278.

17 SECTION 2: This Ordinance, as well as the development agreement adopted by
18 Section 1, shall be recorded in the office of the County Recorder in accordance with the provisions
19 of NRS Chapter 278.

20 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or
21 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
22 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
23 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
24 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
25 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
26 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
27 invalid or ineffective.

28 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,

1 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
2 1983 Edition, in conflict herewith are hereby repealed.
