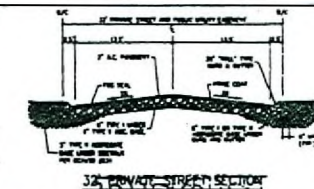
TYPICAL LOT DETAIL
