#20 SUP-22251 We are NOT IN FAVOR of the 248 foot discrepancy in the distance waiver. We recognize the 152 foot width expanse of the ominous Rainbow Boulevard, but DO NOT WANT to ever lessen the integrity of the 400 ft required separation of supper clubs from child care facilities!
