
I am writing this letter concerning the above named Application for a Special Use Permit at 3233 W. Charleston Suite #204. I have previously faxed in my opposition to the request. I am writing this additional letter in opposition as I may not be able to attend the hearing on the 6th due to previous commitments.

My concerns with the Application are the same as those I voiced at the Hearing before the Planning Commission when the Application was denied by all of the Commissioners. While there may be a need for the services rendered by the WIC, those services should be provided in a more appropriate location. Such a location would be one where those using the service are located. The Applicant stated at the hearing that 40 - 60% of the clients come from the 89102 zip code. That means that 40 - 60% of those using the clinic do not come from this zip code. In addition, the 89102 zip code covers an area from Charleston to Spring Mountain and from Decatur to the freeway (with a bit of area to the east of the freeway). The Applicant is not telling the whole story when he advises that such a large percentage come from the 89102 zip code. The clients of the clinic do not come from the immediate area which includes the Rancho Bonita Estates, Rancho Circle, Scotch Eighties, McNeil Estates and similar neighborhoods.

It is our opinion that, in addition to the location being wrong for the above reasons, the parking area becomes crowded and difficult for other professionals in the same center who have been there for years. I have known Dr. Holper, whose clinic has been in the same center for many years, for at least 10 years. I know that he has had his business interfered with as a result of the Applicant's presence. I understand that Dr. Martin's business has also had negative effects as a result of the WIC.

Lastly, the Council should not consider any argument by the Applicant that, since the clinic has already moved there, the Application should be improved. The Applicant noted at the Planning Commissioner's meeting that he has several clinics in the Las Vegas area. Certainly, he should have been aware of the requirements to apply for a Special Use permit. At the very least, the Applicant must have been aware of the need to check for any such requirements. This behavior should not be condoned by granting the Application as a result of the Applicant's failure to follow published rules and procedures.
