Veterans of Foreign Wars Post No. 10057 holds Non-Profit Club General Alcoholic Beverage License No. L13-00013-4-000413. The Complaint for Disciplinary Action submitted alleges that the actual business activity of VFW Post No. 10057 constitutes a public or private nuisance, as it is being conducted in an unlawful, illegal and impermissible manner. Liquor has been sold and consumed by nonmembers, some of whom are underage. A large number of individuals have congregated in the parking lot drinking alcoholic beverages. Employees have worked without a work card or alcohol awareness card. A large number of crimes have occurred at VFW Post 10057 including narcotics offenses, fights, assaults, and batteries, some of which have been weapons related, as well as robberies. Responding to these crimes has resulted in a disproportionate demand on Las Vegas Metropolitan Police resources.

RECOMMENDATION:

Revocation of Non-Profit Club General Alcoholic Beverage License No. L13-00013-4-000413.

All complaints and alligations prior to May of 2007, have already been argued. Both the city of Las Vegas and L.V.M.P.D. stated we were compling and were doing a good job. We then recieved a Unrestricted Licences.

July 13th 2007: Patrica Robeson was cited for not having an Alcohol Awareness Card, when did in fact have one. The officer who issued the complaint wrote on a used ciation, intended for one of the security guards. An attempt was made to contact the officer, however he never returned the calls. Ms. Robeson was also cited for not having availible an employee listing. This is the duty Key Employee. However a copy of the employee listing has been made available for members.

July 19th 2007: A fight involving twenty people. According to the Post sercurity guards and members this fight took place across the street.

September 2nd 2007: The alledged fight involving nine people, were actually nine people assisting an unknown male, who not a guest of the VFW, having a reaction to drugs.

July 30th and September 18th 2007: There were two drug arrest in the parking lot . L.V.M.P.D. was advised of the activies in the parking lot. L.V.M.P.D. were given permission to conduct an iverstigation and to make an arrest anytime they see fit. In situations such as these staff and members are advised to cooperate with L.V.M.P.D. without put themselves in harms way.

October 11th 2007: Two subjects were 86 from the VFW proprieti for fighting. Later returned to the parking lot without the knowledge of the sercurity guards. This resulted in one of subjects getting cut with a box cutter according to L.V.M.P.D.. Efforts were made by security to assist L.V.M.P.D..

November 2nd 2007: We were cited for no Retail Tobacco And Coin-Operated Machine License Posted, the Post does ont have a tabacco machine.

November 7th 2007: There was a family fued that escalated into a robbery.

Of the 188 calls for servivce to L.V.M.P.D., how many were calls after closeing time. The VFW closes no later than 11:30pm every night. Are we really getting equal protection under the law?

In conclusion after carefully reviewing all the complaints and allagaionts, the complaints that were made are typical to the Las Vegas area. Our question to you is why us? There have been robberies, drug use, assaults all over the Las Vegas area.

19 **MAYOR GOODMAN**

20 My watch shows that it's after 11 a.m. and we have a matter, Number 43, which was not to be
21 heard before 11 a.m. Hearing, discussion and possible action regarding complaint seeking
22 disciplinary action against Veterans of Foreign Wars Post No. 10057, 1905 North H Street in Las
23 Vegas, Clark County, Nevada, for violations of the Las Vegas Municipal Code. This is in Ward
24 5.

26 **BRAD JERBIC**

27 Your Honor, before Mr. Henry speaks, I'd like to make a bit of a record here. Yesterday, I'm
28 sorry. Mr. Henry wants to make a record.

29

30 **BILL HENRY**

31 Pardon me, Counsel.

32

33 **BRAD JERBIC**

34 Go ahead.

35

36 **BILL HENRY**

37 Pardon me, Counsel, but if I might, Your Honor, the law requires that before the proceedings can
38 begin, I need to lodge with the Clerk proof of service of notice of today's hearing. And so I'll do
39 that.

40

41 **MAYOR GOODMAN**

42 Okay. All right. The Clerk has received that. Who received service?

43

44 **BILL HENRY**

45 Service was received by the resident agent and by the manager.

46 **MAYOR GOODMAN**

47 All right. Can we have names, please, for the record.

48

49 **BILL HENRY**

50 Yes. Could I have those back, please? Claude Brown at 1320 West Monroe Avenue and Albert

51 Young, 1905 North H Street.

52

53 **MAYOR GOODMAN**

54 All right.

55

56 **BILL HENRY**

57 The former being the resident agent according to the Secretary of State's database.

58

59 **MAYOR GOODMAN**

60 All right. And when was the service made upon both of those gentlemen?

61

62 **BILL HENRY**

63 Each of them was served December 7th with your December 5th order and notice of hearing.

64

65 **MAYOR GOODMAN**

66 Very good. Thank you. All right. Mr. Jerbic, did you wanna be heard?

67

68 **BRAD JERBIC**

69 Very briefly, Your Honor. Yesterday, this came to my attention, that Attorney Rex Bell was

70 retained by the Veterans of Foreign War to represent them at this hearing. I received a call from

71 Mr. Bell and because I was in meetings all day yesterday, I wasn't able to return it until about 5

72 o'clock last night. Mr. Bell told me that he had a funeral to attend today, that he had been

73 retained and he asked for a short continuance in order to represent the VFW at today's hearing. I

74 told him that I would make that representation to the Council and it was a Council decision.

75 Because Mr. Henry was in arguments before the 9th Circuit yesterday, I wasn't able to speak with
76 him until this morning. When I told Mr. Henry of Mr. Bell's request, Mr. Henry brought to my
77 attention the fact that this complaint has got a 60-day window in which it has to be heard. That
78 is jurisdictional. If we continue this to another meeting for Mr. Bell to be present, this complaint
79 will fail for jurisdictional reasons and we'll have to re-file, re-serve and restart the process. With
80 that record made, I made no promises to Mr. Bell as to what this Council would do. I told him I
81 would pass it on and that I did not have an objection to it if the Council did not. But at the same
82 time, I did not know yesterday when I spoke to him that we were within the 60-day window and
83 we could not continue past this particular hearing date. With that, I submit it to the Council and
84 if Mr. Henry has anything to add, this is a good time to do it.

85
86 **BILL HENRY**

87 I'd like to augment the record, briefly.

88
89 **MAYOR GOODMAN**

90 Well, I – I'd like to, before there's any augmentation, I wanna speak on behalf of Councilman
91 Barlow. I – went to Councilman Barlow's office this morning and asked him whether or not any
92 requests had been made concerning this matter to him because he is the Councilman for the
93 particular Ward where the property is located. He said he hadn't heard from anybody. And I
94 said, that surprised me a little bit because I had heard that counsel had been retained for the Post
95 and was going to be seeking a continuance. He said he didn't hear a word and he's ready to go
96 forward. So I felt that I should put that on the record.

97
98 **BILL HENRY**

99 If I might, Mayor, bearing in mind that at least once in the litigation history of the City, a district
100 judge has found that we didn't have a sufficient record for denying a continuance, I'd like to
101 augment the record that, pursuant to law, this matter was brought before the Council in the first
102 instance on December 5th, two thousand and seven, on an agenda item asking that you approve
103 the disciplinary complaint and set the matter for hearing. Also pursuant to law, notice of those

104 proceedings were given. At that hearing, I believe Mr. Young appeared. And the Council, on
105 December 5th, did approve the complaint and set the matter for hearing today. On December 7th,
106 the order approving complaint and notice of hearing was served on the resident agent and Mr.
107 Young.

108 And I would like to read relevantly from the second page of that order. The hearing will be upon
109 the charges in the complaint for disciplinary action which has been served upon you. You may
110 be present at the hearing and you may be represented by a lawyer. You may present any relevant
111 evidence you have and you will be given full opportunity to cross-examine all witnesses
112 testifying against you. You are further notified that within 20 days after service of the complaint
113 for disciplinary action, but not later than five days before the hearing date, you must file with the
114 City Clerk and serve a copy upon the City Attorney of your answer of the charges made in the
115 complaint for disciplinary action and set forth any affirmative offense, defenses you intend raise.
116 So, pursuant to law, they would have had to answer the complaint by the 27th. They did answer
117 the complaint, but they answered it on January 10th, some 13 days late.

118 The consequence of having failed to answer in a timely fashion is set forth in our Municipal
119 Code at 6.88.080 which I, I've put copies of it before each one of you. You know, I'm sorry,
120 but, if I can have your indulgence for just a moment, please.

121

122 **MAYOR GOODMAN**

123 Yeah, because what you put in front of me doesn't have any of the consequences.

124

125 **BILL HENRY**

126 Yeah, you're – correct. What I should have put, again, before you, and I'm sorry, I didn't, is
127 6.88.100. I'll read it to you. Failure to timely file his answer or failure of a respondent or his
128 counsel to appear at the hearing shall constitute an admission of all matters and facts contained
129 in the complaint filed with respect to such respondent. In such cases, the City Council may take
130 action based upon such admission or upon any other evidence. So –

131 **MAYOR GOODMAN**

132 Let me ask you this, we don't have a copy of the answer or the response. It's not, hasn't been
133 made available to us. Could I see that, please?

134

135 **BILL HENRY**

136 Yes.

137

138 **MAYOR GOODMAN**

139 Thank you.

140

141 **BILL HENRY**

142 I went with Mr. Young and witnessed him serving it on the City Clerk on the same date.

143

144 **MAYOR GOODMAN**

145 All right. Well, apparently this is a response which was filed by Albert Young, Canteen
146 Manager for the Veterans of Foreign Wars for Post Number ten, 10057. There, it was received
147 January the 10th as was represented by Counsel. Could you tell me, first identify yourself.

148

149 **ALBERT YOUNG**

150 Albert Young.

151

152 **MAYOR GOODMAN**

153 Mr. Young, why – wasn't this served within the 20 days? Do you have a – a reason for it?

154

155 **ALBERT YOUNG**

156 Well, it wasn't unclear. It was not clear. We didn't have counsel at the time that we served it, so
157 we did the best we could at the time.

158 **MAYOR GOODMAN**

159 Let me ask – the City Attorney. Even though it's in the mandatory, that they shall do certain
160 things, for good cause shown, I – could allow them to file this on a late basis, could I not?

161

162 **BRAD JERBIC**

163 That, there is precedent for this. I – do believe the law requires that they file by a particular date,
164 but we've had situations where people have not filed at all and this Council's decided to have a
165 hearing in spite of that, so there is precedent for that, Your Honor.

166

167 **MAYOR GOODMAN**

168 All right. Well, I think – that based on all the equities here, I will receive this, I think it's
169 important, however, Mr. Henry, that the Council will receive a copy of this in anticipation of
170 what we're going to be doing today. Could we have copies made of this, please?

171

172 **BEVERLY BRIDGES**

173 It's in your backup, Sir, in the green copy.

174

175 **MAYOR GOODMAN**

176 In the back here, this is the answer that we're referring to? All right. Fine. All right, we'll, let's
177 make this part of the record as it was. And let me hear, Mr. Young, as far as the request for a
178 continuance here. I want you to make your record on that, unless Mr. Henry, you have
179 something you want to add in addition to what you said concerning starting today.

180

181 **BILL HENRY**

182 No. I – would just point out that if we do continue this, if you were to continue it, the next
183 regularly scheduled meeting of the City Council is on the 6th of February which would take you
184 outside the 60 days and you'd lose jurisdiction over the complaint that you've approved.

186 Assuming, however, that we could enter into a stipulation extending it or not.

187 **BILL HENRY**

188 I –

190 **MAYOR GOODMAN**

191 Or is it jurisdictional?

192

193 **BILL HENRY**

194 I believe it's jurisdictional.

195

196 **MAYOR GOODMAN**

197 All right, then it would require for us setting it for a special hearing prior to the – expiration of
198 the 60 days.

199

200 **BILL HENRY**

201 The problem, yes, but the problem with that is that it would be potentially dangerous because
202 State law requires that notice of hearing be given to the respondent in a particular fashion and
203 that fashion doesn't admit to the respondent being present before you and agreeing that he has
204 notice. It has to be done in writing. And so, if you were to reset it, and I was unable to serve
205 them in writing, then under State law, you wouldn't be able to go forward with this newly set
206 hearing.

207

208 **MAYOR GOODMAN**

209 All right. I understand that. Now, Mr. Young, I'm gonna allow you to tell us why you want to
210 have this continued, then I'm going to turn to Councilman Barlow and have him give me some
211 direction as to what he desires to do and what he will – tell us will have large bearing on what
212 action we're gonna take. Just – the issue of why you would like us to continue this.

216 attorney, no one want to go against City Hall. We finally found – one at the last moment and
217 here we are.

219 **MAYOR GOODMAN**

220 Okay. Well, I want to make the record clear, you're not against City Hall. We're here, at least
221 I'm here, and my Council's here to listen to the facts and then to make a decision based on those
222 facts. I don't have any predetermination one way or the other and want you to know that
223 whatever we're gonna do, it's gonna be done on a level playing field here. But, Councilman
224 Barlow.

225

226 **COUNCILMAN BARLOW**

227 Thank you, Mayor. I, too, wanna make sure that the VFW Post 10057 have due process and
228 have access to an attorney who, in fact, will be able to represent them in the best way possible,
229 so I would like to move forward to allow this to be continued in order to make sure that the VFW
230 Post 10057 have an opportunity to be represented on a level playing field.

232 **MAYOR GOODMAN**

233 All right. Thank you, Sir. Assume that Mr. Young agrees to stick around, would you be able to
234 get written notice to him today if we are able to find a date which is agreeable to you, Mr. Henry
235 and Mr. Young, as well as the Council, to have a hearing. Because, I'll tell ya, there are a lot of
236 people out there who may wanna be heard and it may take more than the ordinary amount of
237 time to conduct a hearing with these kind of serious allegations.

240 I can do that.
